### Planned Activities For Next 30 Days:

- 2. SES will proceed to work on the Final Design for this project.
- Continue to coordinate this project with FBC, FBCDD, TDCJ, TXDOT, GPTRA and PGAL.
- 4. SES and subproviders will continue to work on the right of way and topographic survey requirements for this project for the proposed detention pond location.
- SES and subproviders will continue to work on the geotechnical engineering/investigation requirements for this project for the proposed detention pond location.
- 6. SES and subproviders will continue to work on the traffic signal warrant study and traffic signal design requirements with PGAL and TXDOT for this project.
- SES will continue to coordinate this project with existing public and private utilities for this project.
- 8. SES will continue to coordinate the required detention pond area requirements with TDCJ. SES has initiated preliminary detention pond requirements that will have to be acquired by FBC from TDCJ.

- 9. LJA/FBC will secure environmental clearance for this project.
- 10. LJA/FBC will provide project area historical aerials in an effort to rule out any historical structures, artifacts, previous burial grounds, etc.....
- 11. FBC will follow up with TDCJ and continue discussions for proposed detention pond land acquisition.
- 12. LJA has reviewed the SUE Proposal submitted by SES and Halff and have submitted the supplemental contract documents to FBC for FBCCC approval. This proposal was approved by FBC and FBCCC. The SUE is required for this project to confirm the existing horizontal/vertical TDCJ water line locations parallel to John Sharp Drive,
