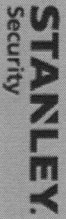

INSTALLATION NOTES:

Per camera storage calculation, the existing 4TB hard drive Pelco NVR will support 10 - 3MP cameras with 40% motion, at 7fps for 30 days.

The NVR currently has 7 existing 2MPs cameras installed and we are adding 3 more 2MP cameras for a total of 10.

The storage calculations state that 2TB is all that is needed for 10 - 3MP cameras, so there is still 2TB additional unused storage space.
