Power of Attorney

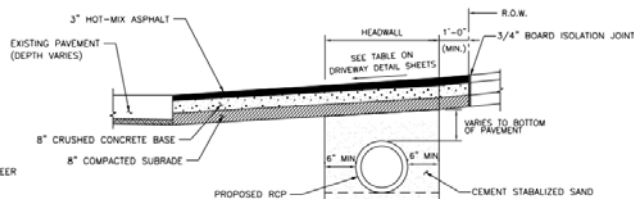

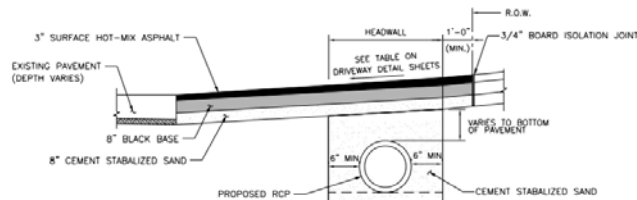
