KNOW ALL BY THESE PRESENTS:

**FIRST AMENDMENT TO NON-PROFIT SUBRECIPIENT AGREEMENT  
BETWEEN FORT BEND COUNTY  
AND  
LITERACY COUNCIL OF FORT BEND COUNTY**

THIS FIRST AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County" or "Grantee"), a body corporate and politic under the laws of the State of Texas, and Literacy Council of Fort Bend County, a non-profit corporation under the laws of the State of Texas, (hereinafter "Subrecipient").

WHEREAS, the parties have executed and accepted that certain Non-Profit Subrecipient Agreement Between Fort Bend County and Literacy Council of Fort Bend County (the "Agreement"), on or about February 28, 2023; and

WHEREAS, the following changes are incorporated as if a part of the original Agreement incorporated by reference in the same as if fully set forth verbatim herein;

**NOW, THEREFORE**, the parties do mutually agree as follows:

1. In Section I "SCOPE OF SERVICE" Subsection E "Service Area", the paragraph that states the following:

"The Subrecipient will use the grant funds to pay for activities benefitting clients who live within the unincorporated areas of Fort Bend County, or within the incorporated limits of the following cities: Arcola, Beasley, Fairchilds, Fulshear, Kendleton, Meadows Place, Needville, Orchard, Pleak, Richmond, Rosenberg, Simonton, Stafford and Thompsons. The Subrecipient will not use the grant funds to pay for activities benefiting clients who live within the cities of Houston, Katy, Missouri City, Weston Lakes or Sugar Land."

shall be replaced with the following paragraph:

"The Subrecipient will use the grant funds to pay for activities benefiting clients who live within the unincorporated areas of Fort Bend County, or within the incorporated limits of the following cities: Arcola, Beasley, Fairchilds, Fulshear, Kendleton, Meadows Place, Needville, Orchard, Pleak, Richmond, Rosenberg, Simonton, Sugar Land, Stafford and Thompsons. The Subrecipient will not use the grant funds to pay for activities benefiting clients who live within the cities of Houston, Katy, Missouri City, Pearland, and Weston Lakes."

Except as provided herein, all terms and conditions of the Agreement, including any addenda or amendments, not modified shall remain in full force and effect. If there is a conflict between this Amendment and the Agreement, the provisions of this Amendment shall prevail with regard to the conflict.
