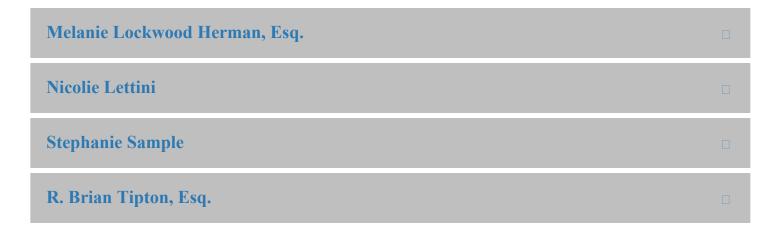
- Describe proposed updates to the Uniform Grants Guidance.

Eastern Grants Forum 2023 is intended for all members of the grant-funded community: governing body members, officers, executives, managers, fiscal staff, program staff, and other grants management professionals.
