As requested by Rivers Run at the Brazos HOA, Fort Bend County Engineering Department has completed the traffic control plan to prohibit parking on both sides of Mariella Drive between Grace Court and Rohan Road (24 hours), on the north side of the Mariella Drive at Grace Court intersection (24 hours), on both sides of Summerville Drive between Honeysuckle Vine Drive and Benton Road (24 hours), and on the west side of Honeysuckle Vine Drive fronting the HOA park (10 pm to 6 am). The public hearing date for acceptance for the plan will be scheduled on the next available Commissioner's Court Agenda.
