Dear Court Leader,

The National Center for State Courts (NCSC) was founded in 1971 at the urging of the late Chief Justice of the United States Warren E. Burger. The NCSC's mission has remained consistent: improving the administration of justice through leadership, research, education, technology, and consulting services.

Every other year, the NCSC sponsors the Court Technology Conference (CTC) designed to improve court efficiencies and effectiveness by educating court professionals about the latest breakthroughs and best practices in court technology. CTC 2023 is being held in Phoenix, AZ, September 12-14.

CTC provides judges, court administrators, court managers, technologists, and others with two and a half days of learning and networking with industry experts at the world's largest court technology conference. Here's how one attendee explained CTC's value:

"This is the most productive conference that I have ever attended. This is probably due to relevance of the sessions to our project, and we also see where technology is headed."

NCSC is the only national court organization dedicated to helping the justice system use technology to improve services, reduce costs, and increase accountability. Average cost for CTC 2023 includes:

- Registration: \$800-\$900 (depending on when you register)

We invite you to submit session ideas for Court Technology Conference (CTC) 2023 in Phoenix, AZ, September 12-14. CTC is a multitrack event offering many session choices that cover various topics. We are interested in showcasing technology improvements for both back-end administrators and the general public.

## Track 1 | Continuity of Operations and Cybersecurity

Sessions in this track will highlight effective planning, policy, and response measures related to maintaining operations and court security (including cybersecurity). Many courts have experienced cybersecurity incidents as well as disruptive weather events.

## Track 2 | Digital Courts – Evidence, Language Access, ChatBots

A growing number of court information exchanges are born digitally. Courts receive case filings and digital evidence in ways that stretch far beyond scanning paper documents into PDF files. Courts also use digital tools for language access and communication with the public and court participants. This track will examine how courts use these approaches in their workflow, ways these tools can improve access to justice, and potential issues/challenges when using these methods.

## Track 3 | Remote Justice: Online Hearings and Beyond

Courts quickly moved to remote justice during the pandemic. Lessons were learned, and many practices are here to stay. But remote justice is more than online hearings. It covers a host of services and actions that move a case forward. Guided forms, easy case filing, online mediation, online payment plans, and other digital interfaces are growing. This track will focus on the (r)evolution to support and improve the user experience.

## Track 4 | Data is the Center of It All

There are a lot of big ideas on how technology can improve efficiency, fairness and access while also broadening the scope of services. Yet none of this progress is possible without good data. This track will explore opportunities and challenges related to proper use of court data like data warehousing, governance, integration, information sharing and data definitions.

## Track 5 | Innovation, Ethics, and the Future using Al Tools

We have heard about AI and its pitfalls for many years now. Just as AI tools have evolved, so have best practices and protocols designed to address ethical concerns. This track will focus on how we make AI fair, potential bias, privacy considerations and proper application of AI tools.

## Track 6 | Wildcard
