RE: Addition of "NO PARKING, STOPPING, STANDING" signs on Chimney Rock Road and Hawthorne Brook in Winfield Lakes Sections 8, 9, and 16

As requested by Fort Bend Independent School District, Fort Bend County Engineering Department has completed the traffic control plan to prohibit parking, stopping, and standing on both sides of Chimney Rock Road between Tabor Mills Drive and Hawthorne Brook Lane, and on both sides of Hawthorne Brook Lane between Feather Green Trail and Windy Vale Trail. This prohibition will be effective on school days from 7:00 a.m. to 8:30 a.m. and from 2:30 p.m. to 4:00 p.m. The public hearing date for acceptance for the plan will be scheduled on the next available Commissioner's Court Agenda.


