

**RESOLUTION AND ORDER TO INCLUDE AREA IN  
FORT BEND COUNTY ASSISTANCE DISTRICT NO. 2**

On this \_\_\_\_\_ day of \_\_\_\_\_, 2023, at a duly posted and called meeting of the Fort Bend County Assistance District No. 2 (“CAD No. 2”), acting by and through the Commissioners Court of Fort Bend County, sitting as its Board of Directors (the “Board of Directors”), on motion of Commissioner \_\_\_\_\_, seconded by Commissioners \_\_\_\_\_, duly put and carried:

WHEREAS, on November 22, 2011, the Fort Bend County Commissioners Court, by Order, established and organized CAD No. 2 pursuant to its authority under Chapter 387 of the Texas Local Government Code; and

WHEREAS, Fort Bend County, Texas, a political subdivision of the state of Texas (“County”), owns, in fee simple, certain real property having Fort Bend Central Appraisal District (“FBCAD”) Property ID No.’s R86697, R86696, and R86695 (collectively, the “Annexation Area”), which property is further described and identified on Exhibit “A” attached hereto and incorporated by reference for all intents and purposes; and

WHEREAS, County has petitioned CAD No. 2 to include the Annexation Area within the boundaries of said district; and

WHEREAS, Section 387.003(i) of the Texas Local Government Code authorizes the Board of Directors, by Order, to include an area in a County Assistance District, without an election, on receipt of petition signed by a majority of the landowners in the proposed area to be included, provided that there are no registered voters within said area; and

WHEREAS, the Board of Directors finds that there are no registered voters within the Annexation Area.

NOW THEREFORE, BE IT RESOLVED AND ORDERED that the Fort Bend County Commissioners Court sitting as the Board of Directors of CAD No. 2:

1. Finds and declares that the matters and facts set out in the preamble of this Resolution and Order are hereby true and complete and are incorporated herein.
2. Pursuant to Section 387.003(i) of the Texas Local Government Code, includes within the boundaries of CAD No. 9 the Annexation Area, which properties have FBCAD Property ID No.'s R86697, R86696, and R86695 and are further described and identified on Exhibit "A" attached hereto.

BE IT FURTHER RESOLVED AND ORDERED that this Resolution and Order shall be immediately effective upon passage.

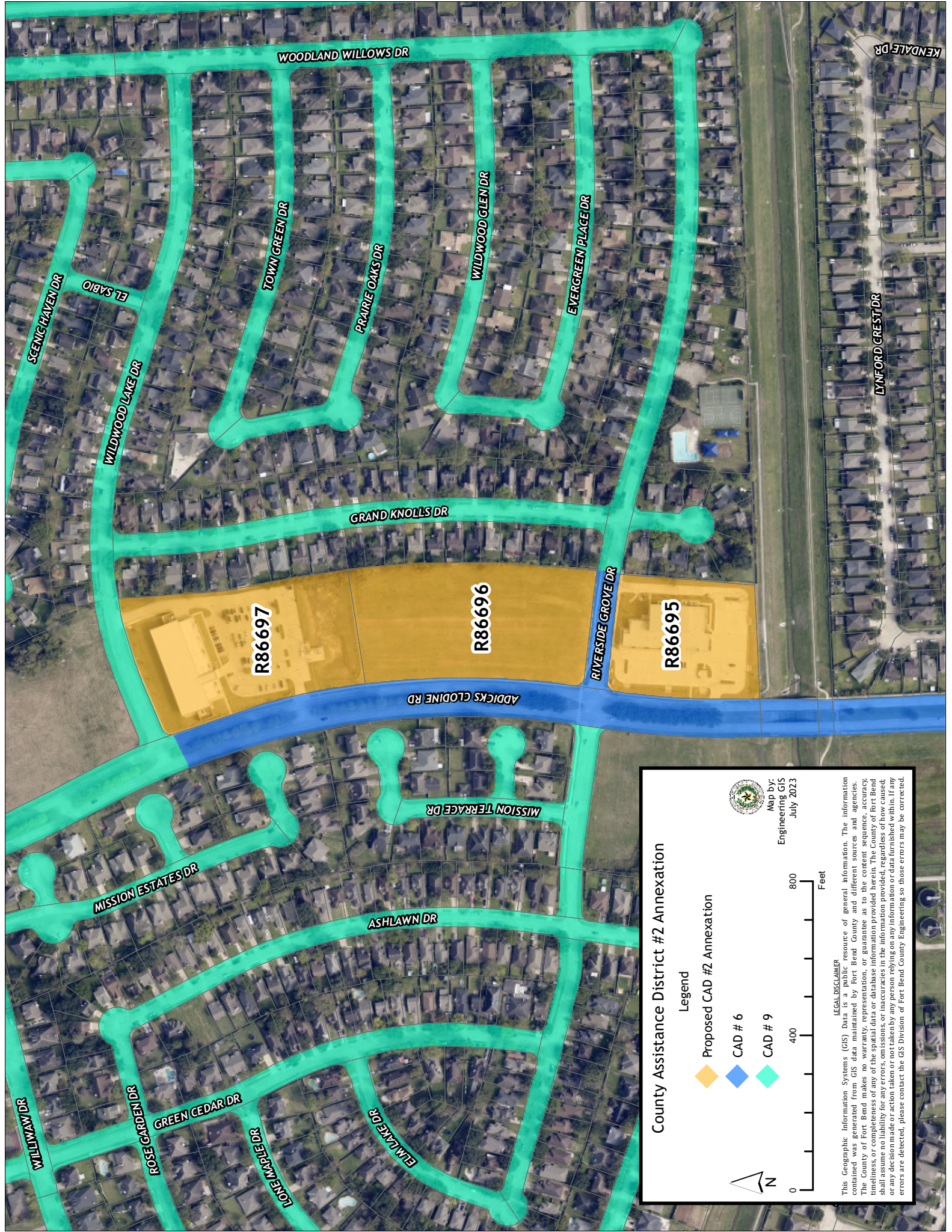
