KNOW ALL MEN BY THESE PRESENTS:

COUNTY OF FORT BEND §

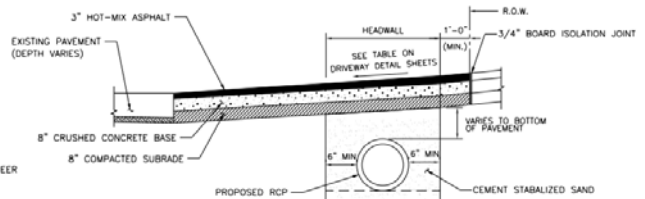
