## **EMERGENCY SOLUTIONS GRANTS CV PROGRAM**

### **FOURTH AMENDMENT TO SUBRECIPIENT AGREEMENT BETWEEN FORT BEND COUNTY AND FRED & MABEL R. PARKS YOUTH RANCH, INC.**

THIS FOURTH AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter “County” or “Grantee”), a body corporate and politic under the laws of the State of Texas, and the Fred & Mabel R. Parks Youth Ranch, Inc., a non-profit corporation under the laws of the State of Texas, (hereinafter “Subrecipient”).

WHEREAS, the parties have executed and accepted that certain Subrecipient Agreement between Fort Bend County and the Fred & Mabel R. Parks Youth Ranch, Inc. (the “Agreement”), on or about June 23, 2020, and as amended on January 14, 2021, January 17, 2022, and May 18, 2022; and

WHEREAS, the following changes are incorporated as if a part of the original Agreement incorporated by reference in the same as if fully set forth verbatim herein;

**NOW, THEREFORE**, the parties do mutually agree as follows:

1. Section II “TIME OF PERFORMANCE” shall be extended ending on September 30, 2023.
2. The total payment amount listed in Section V “PAYMENT” is hereby increased by an amount not to exceed One Hundred Thousand Five Hundred Seventy dollars and no cents (\$100,570.00), authorized as follows:

\$7,314.00 under the Agreement; and  
\$164,934.00 under the First Amendment; and  
\$179,748.00 under the Second amendment; and  
\$100,570.00 under this Fourth Amendment

for a total contract amount not to exceed Four hundred Fifty-Two Thousand Five Hundred Sixty-Six dollars and no cents (\$452,566.00).

3. In no case shall the amount paid by County to Subrecipient under the Agreement or this Amendment exceed the to total payment amount without an approved amendment mutually agreed to by both parties.
4. Except as provided herein, all terms and conditions of the Agreement, including any addenda or amendments, not modified shall remain in full force and effect. If there is a conflict between this Amendment and the Agreement, the provisions of this Amendment shall prevail with regards to the conflict.
