

#### Investigations

- 1. Dell Latitude 5430 Rugged Mobile Data Terminal (MDT) for Investigators, priced at \$1,735.00 per unit for a total cost of \$5,250.00 for three (3) units.
- 2. Motorola APX 6000 Model P25 Portable Radio with Wi-Fi and Bluetooth capacity. Integrated Body Camera included. Priced at \$4,011.54 per unit for a total cost of \$8,023.08 for two (2) units.
  - a. Motorola APX 6000 Model P25 Single Unit Charger and Microphone with 3.5MM Jack, priced at \$254.79 per unit for a total cost of \$509.58 for two (2) units.

#### **Justification**

1. <u>Mobile Data Terminals</u>: Mobile Data Terminals (MDTs) are electronic devices similar to laptops investigators use to access information in the field. MDTs allow field investigators to interface with law enforcement databases in real time, giving them the most up-to-date information on victims, witnesses, and suspects during an investigation. MDTs typically include a keyboard, a display screen, and a printer. They may also have features like GPS navigation and mapping capabilities or voice recognition software. These units provide a more secure and reliable internet connection and eliminate the need for investigators to use hotspot connections through their cell phones while working in the field.

2. Four-Channel Portable Radios: These radios are used in the field during investigations or while working protection detail for the District Attorney at various public appearances. These devices allow investigators to communicate discreetly with each other during undercover operations, in large group gatherings, or in other public settings to ensure the safety and security of investigators or the District Attorney during appearances. Radios have Wi-Fi and Bluetooth capabilities and an integrated body camera that automatically activates when placed in emergency mode. These radios will replace two of the oldest, outdated models.

These requests enable our investigators to be mobile and provide quick access to critical information as they perform timely and comprehensive investigations, allowing them to perform their responsibilities efficiently and effectively. Thank you for your consideration.







The Fort Bend County Sheriff's Office seeks funds from the above-named solicitation for the purchase of

- 30 North American Rescue (NAR) Headrest Individual First Aid Kits (IFAK) with Combat Gauze and 30 stainless steel Trauma Shears
- 12 IDEMIA IDent 2.0 Mobile Automated Fingerprint Identification Systems (AFIS)

The total funding sought for the IFAKs, trauma shears, and Mobile AFIS is \$31,335.80.

### **Description:**

NAR IFAKs and Trauma Shears provide compact, portable critical trauma care equipment to treat gunshot wounds, stabbings, and other injuries that Deputies might sustain themselves or encounter in accident or crime victims, or in suicide and other self-harm attempts. The IFAK contains chest seals to treat gunshot wounds (entry and exit points), wound packing gauze, and hemostatic dressing (Combat Gauze) impregnated with blood clotting agents. It also contains two tourniquets, a compression bandage, wound dressing, CPR mask, fentanyl resistant gloves, small bandages, and an emergency survival blanket, which can prevent hypothermia in the event of a hemorrhage. These are essential items for in situ treatment while waiting for EMS to arrive and Sheriff's Office backup. The rounded-tip NAR Trauma Shears can safely cut through the toughest materials, including law enforcement uniforms, providing quick access to the wound site for immediate treatment, which can mean the difference between life and death.

**Mobile AFIS** is a hand-held, Android based, FBI-Certified fingerprinting device for use in the field. Using USB and Bluetooth mobile connection, it can easily and quickly capture up fingerprints for submission and search in a range of criminal databases. The device will provide a hit/non-hit indication, mugshot, and subject name. It also comes with a rear-facing camera to easily capture a facial image while capturing a subject's fingerprints. A 2005 article published in the journal, *Law Enforcement Technology*, describes this device as a "Match Made in Heaven," one that reaps the benefits of a wireless-biometric technology marriage (Volume: 32 Issue: 4, p. 1).

### Purpose:

In the application for funding under last year's 2022 JAG award, the Sheriff's Office sought funding for 165 IFAKs totaling \$34,029. We were generously awarded funding that would cover the purchase of 119 units. However, between the award of funds and the actual receipt of funds, which has been nearly a year, the cost of the IFAKs has risen by nearly \$40.00, reducing the number of units we can purchase. The 30 units for which we seek funding will allow us to reach the original 165 request. Prior to this award, none of FBCSO's patrol vehicles were outfitted with first aid or trauma care kits.

The NAR IFAKs and trauma shears address the emergency first aid and trauma care needs of law enforcement officers, who put themselves in harm's way every minute they are in uniform. The IFAKs and shears are foremost for their own protection and preservation, as in the current milieu law enforcement officers are frequently targeted by violent individuals. Increasingly, however, FBC Deputies are the first on the scene of an accident, shooting, suicide attempt, and other scenes where critical medical care is necessary, thus trauma care supplies are also to treat accident victims, victims of violent crimes, and other injured FBC residents.

As population rises in Fort Bend County, so too does crime. For example, 2023 YTD, compared to the same reporting period in 2022, Robbery has increased by 25.3%, and use of a firearm when committing a robbery has increased by 48.3%. The Mobile AFIS units will allow for Sheriff's Office Deputies and Investigators to quickly and accurately check a person's identity, including individuals suspected of using a firearm in the commission of a robbery. These devices will enable law enforcement to identify individuals who refuse to provide identification or provide false credentials, to identify persons found wandering without ID, to identify individuals involved in traffic accidents (and to notify family members if necessary), to identify victims of traffic fatalities when no ID is found at the scene, and to identify individuals who are deceased. These devices also enable Deputies and Investigators to check individuals for possible outstanding warrants and to confirm mistaken-identity claims. In addition to allowing for quick and rapid identification, these devices obviate need to bring a subject to the County jail for fingerprint identification—a time-consuming activity that takes Deputies away from other, perhaps more critical law enforcement work.

### **Performance Goals:**

The acquisition of 30 IFAKs with trauma shears will equip our *entire* patrol fleet vehicles with portable trauma kits so that wounded FBC law enforcement personnel have improved odds of surviving a violent attack, accident, or other injury sustained in the line of duty. This tactical medical equipment will also result in a larger number of first responders having the necessary tools to render aid to FBC citizens. By equipping our Deputies with portable IFAK and trauma shears, tools that can save citizens' lives, we make communities and policing safer throughout Fort Bend County and build public trust.

Currently, FBCSO has four (4) Mobile AFIS devices: two (2) in the Warrants Division and two (2) in the Crime Scene Unit, but these are often unavailable for use in the field, and if they are, they are logistically difficult to obtain while performing the law enforcement tasks that would require their use. Deputies and Investigators regularly rely on Harris County Sheriff's Office and/or Houston Police Department for a Mobile AFIS loan. This, too, is a logistical challenge and a waste of valuable time. The acquisition of 12 units for Patrol and the Criminal Investigation Division will make for more efficient, accurate, and safe policing. Subjects can be identified quickly and easily in the field, and if they are determined to be dangerous, deputies can take them off the street immediately, keeping both law enforcement officers and the citizens of FBC safe.

Fort Bend County Sheriff's Office recognizes the sizeable cost to properly outfit field operations personnel with the requested equipment. Our request is urgent and critical, but it is scalable should the Committee elect to award less than the full amount.

In this Exhibit A, the term "Licensor" means Idemia Identity & Security USA LLC, ("IDEMIA"); "Licensee," means the Customer; "Primary Agreement" means the agreement to which this exhibit is attached (IDEMIA Short Form Sales Agreement); and "Agreement" means this Exhibit and the applicable terms and conditions contained in the Primary Agreement. The parties agree as follows:

For good and valuable consideration, the parties agree as follows:

### **SECTION 1. DEFINITIONS**

- 1.1 "Designated Products" means products provided by IDEMIA to Licensee with which or for which the Software and Documentation is licensed for use.
- 1.2 "Documentation" means product and software documentation that specifies technical and performance features and capabilities, and the user, operation and training manuals for the Software (including all physical or electronic media upon which such information is provided).
- 1.3 "Open Source Software" means software with either freely obtainable source code, license for modification, or permission for free distribution.
- 1.4 "Open Source Software License" means the terms or conditions under which the Open Source Software is licensed.
- 1.5 "Primary Agreement" means the agreement to which this exhibit is attached (IDEMIA Short Form Sales Agreement).
- 1.6 "Security Vulnerability" means a flaw or weakness in system security procedures, design, implementation, or internal controls that could be exercised (accidentally triggered or intentionally exploited) and result in a security breach such that data is compromised, manipulated or stolen or the system damaged.
- 1.7 "Software" (i) means proprietary software in object code format, and adaptations, translations, de-compilations, disassemblies, emulations, or derivative works of such software; (ii) means any modifications, enhancements, new versions and new releases of the software provided by IDEMIA; and (iii) may contain one or more items of software owned by a third party supplier. The term "Software" does not include any third party software provided under separate license or third party software not licensable under the terms of this Agreement.

### **SECTION 2. SCOPE**

This Agreement contains the terms and conditions of the license IDEMIA is providing to Licensee, and Licensee's use of the Software and Decementation.

### **SECTION 3. GRANT OF LICENSE**

- 3.1. If requested by Licensee, IDEMIA will use commercially reasonable efforts to: (i) determine whether any Open Source Software is provided under this Agreement; (ii) identify the Open Source Software and provide Licensee a copy of the applicable Open Source Software License (or specify where that license may be found); and, (iii) provide Licensee a copy of the Open Source Software source code, without charge, if it is publicly available (although distribution fees may be applicable).

### **SECTION 4. LIMITATIONS ON USE**

4.1. Licensee may use the Software only for Licensee's internal business purposes and only in accordance with the Documentation.

Any other use of the Software is strictly prohibited. Without limiting the general nature of these restrictions, Licensee will not make the Software available for use by third parties on a "time sharing," "application service provider," or "service bureau" basis or for any other similar commercial rental or sharing arrangement.

- Licensee will not, and will not allow or enable any third party to: (i) reverse engineer, disassemble, peel components, decompile, reprogram or otherwise reduce the Software or any portion to a human perceptible form or otherwise attempt to recreate the source code; (ii) modify, adapt, create derivative works of, or merge the Software; (iii) copy, reproduce, distribute, lend, or lease the Software or Documentation to any third party, grant any sublicense or other rights in the Software or Documentation to any third party, or take any action that would cause the Software or Documentation to be placed in the public domain; (iv) remove, or in any way alter or obscure, any copyright notice or other notice of IDEMIA's proprietary rights; (v) provide, copy, transmit, disclose, divulge or make the Software or Documentation available to, or permit the use of the Software by any third party or on any machine except as expressly authorized by this Agreement; or (vi) use, or permit the use of, the Software in a manner that would result in the production of a copy of the Software solely by activating a machine containing the Software. Licensee may make one copy of Software to be used solely for archival, back-up, or disaster recovery purposes; provided that Licensee may not operate that copy of the Software at the same time as the original Software is being operated. Licensee may make as many copies of the Documentation as it may reasonably require for the internal use of the Software.
- 4.3. Unless otherwise authorized by IDEMIA in writing, Licensee will not, and will not enable or allow any third party to: (i) install a licensed copy of the Software on more than one unit of a Designated Product; or (ii) copy onto or transfer Software installed in one unit of a Designated Product onto another device. Licensee may temporarily transfer Software installed on a Designated Product to another device if the Designated Product is inoperable or malfunctioning, if Licensee provides written notice to IDEMIA of the temporary transfer and identifies the device on which the Software is transferred. Temporary transfer of the Software to another device must be discontinued when the original Designated Product is returned to operation and the Software must be removed from the other device. ### SECTION 5. OWNERSHIP AND TITLE

IDEMIA, its licensors, and its suppliers retain all of their proprietary rights in any form in and to the Software and Documentation, including, but not limited to, all rights in patents, patent applications, inventions, copyrights, trademarks, trade secrets, trade names, and other proprietary rights in or relating to the Software and Documentation (including any corrections, bug fixes, enhancements, updates, modifications, adaptations, translations, de-compilations, modifications, adaptations, translations, de sommended, disassemblies, emulations to or derivative works from the Software or Documentation, whether made by IDEMIA or another party, or any improvements that result from IDEMIA's processes or, provision of information services). No rights are granted to Licensee under this Agreement by implication, estoppel or otherwise, except for those rights which are expressly granted to Licensee in this Agreement. All intellectual property developed, originated, or prepared by IDEMIA in connection with providing the Software, Designated Products, Documentation or related services, remains vested exclusively in IDEMIA, and Licensee will not have any shared development or other intellectual property rights.

### SECTION 6. LIMITED WARRANTY; DISCLAIMER OF WARRANTY

- 6.1. If Licensee is not in breach of any of its obligations under this Agreement, IDEMIA warrants that the unmodified Software, when used properly and in accordance with the Documentation and this Agreement, will be free from a reproducible defect that eliminates the functionality or successful operation of a feature critical to the primary functionality or successful operation of the Software. Whether a defect occurs will be determined by IDEMIA solely with reference to the Documentation. IDEMIA does not warrant that Licensee's use of the Software or the Designated Products will be uninterrupted, error-free, completely free of Security Vulnerabilities, or that the Software or the Designated Products will meet Licensee's particular requirements. IDEMIA makes no representations or warranties with respect to any third party software included in the Software.
- 6.2 IDEMIA's sole obligation to Licensee and Licensee's exclusive remedy under this warranty is to use reasonable efforts to remedy any material Software defect covered by this warranty. These efforts will involve either replacing the media or attempting to correct significant, demonstrable program or documentation errors or Security

Vulnerabilities. If IDEMIA cannot correct the defect within a reasonable time, then at IDEMIA's option, IDEMIA will replace the defective Software with functionally-equivalent Software, license to Licensee substitute Software which will accomplish the same objective, or terminate the license and refund the Licensee's paid license fee.

- 6.3. Warranty claims are described in the Primary Agreement.
- 6.4. The express warranties set forth in this Section 6 are in lieu of, and IDEMIA disclaims, any and all other warranties (express or implied, oral or written) with respect to the Software or Documentation, including, without limitation, any and all implied warranties of condition, title, non-infringement, merchantability, or fitness for a particular purpose or use by Licensee (whether or not IDEMIA knows, has reason to know, has been advised, or is otherwise aware of any such purpose or use), whether arising by law, by reason of custom or usage of trade, or by course of dealing. In addition, IDEMIA disclaims any warranty to any person other than Licensee with respect to the Software or Documentation.

### **SECTION 7. TRANSFERS**

Licensee will not transfer the Software or Documentation to any third party without IDEMIA's prior written consent. IDEMIA's consent may be withheld at its discretion and may be conditioned upon transferee paying all applicable license fees and agreeing to be bound by this Agreement.

### **SECTION 8. TERM AND TERMINATION**

- 8.1 Licensee's right to use the Software and Documentation will begin when the Primary Agreement is signed by both parties and will continue for the life of the Designated Products with which or for which the Software and Documentation have been provided by IDEMIA, unless Licensee breaches this Agreement, in which case this Agreement and Licensee's right to use the Software and Documentation may be terminated immediately upon notice by IDEMIA.

If Licensee breaches this Agreement, IDEMIA may terminate this Agreement and be entitled to all available remedies at law or in equity (including immediate injunctive relief and repossession of all non-embedded Software and associated Documentation unless Licensee is a Federal agency of the United States Government).

### SECTION 9.UNITED STATES GOVERNMENT LICENSING PROVISIONS & RESTRICTED RIGHTS LEGEND

This Section applies if Licensee is the United States Government or a United States Government agency. Licensee's use, duplication or disclosure of the Software and Documentation under IDEMIA's copyrights or trade secret rights is subject to the restrictions set forth in subparagraphs (c)(1) and (2) of the Commercial Computer Software-Restricted Rights clause at FAR 52.227-19 (JUNE 1987), if applicable, unless they are being provided to the Department of Defense. - 11.1. COPYRIGHT NOTICES. The existence of a copyright notice on the Software will not be construed as an admission or presumption of publication of the Software or public disclosure of any trade secrets associated with the Software.
- 11.2. COMPLIANCE WITH LAWS. Licensee acknowledges that the Software is subject to the laws and regulations of the United States and Licensee will comply with all applicable laws and regulations, including export laws and regulations of the United States. Licensee will not, without the prior authorization of IDEMIA and the appropriate governmental authority of the United States, in any form export or reexport, sell or resell, ship or reship, or divert, through direct or indirect means, any item or technical data or direct or indirect products sold or otherwise furnished to any person within any territory for which the United States Government or any of its agencies at the time of the action, requires an export license or other governmental approval. Violation of this provision is a material breach of this Agreement.
- 11.3. GOVERNING LAW. This Agreement is governed by the laws of the United States to the extent that they apply and otherwise by the internal substantive laws of the State to which the Software is shipped if Licensee is a sovereign government entity, to the extent they do not conflict with the laws of the United States, or the internal substantive laws of the State of Delaware if Licensee is not a sovereign government entity. - 11.4. THIRD PARTY BENEFICIARIES. This Agreement is entered into solely for the benefit of IDEMIA and Licensee. No third party has the right to make any claim or assert any right under this Agreement, and no third party is deemed a beneficiary of this Agreement. Notwithstanding the foregoing, any licensor or supplier of third party software included in the Software will be a direct and intended third party beneficiary of this Agreement.
- 11.5. PREVAILING PARTY. In the event of any dispute arising out of the subject matter of this Agreement, the prevailing party shall recover, in addition to any other damages assessed, its reasonable attorneys' fees and court costs incurred in arbitrating, litigating, or otherwise settling or resolving such dispute.
- 11.6 SURVIVAL. Sections 4, 5, 6.3, 7, 8, 9, 10, and 11 survive the termination of this Agreement.
