**AMENDMENT NO. 4 TO AURIGO SOFTWARE SUBSCRIPTION SERVICES AND IMPLEMENTATION AGREEMENT – R18-062
(18-ENG-500038-A3)**

THIS AMENDMENT NO. 4 TO AURIGO SOFTWARE SUBSCRIPTION SERVICES AND IMPLEMENTATION AGREEMENT – R18-062 (“Amendment”) between Fort Bend County, (“County”), a body corporate and politic under the laws of the State of Texas, and Aurigo Software Technologies Inc. (“Aurigo”), a company authorized to conduct business in the State of Texas, (each a “Party” and collectively the “Parties”).

WITNESSETH

WHEREAS, the Parties executed the AURIGO SOFTWARE SUBSCRIPTION SERVICES AND IMPLEMENTATION AGREEMENT – R18-062 on December 18, 2018 (the “Existing Agreement”), and available at Aurigo Software Subscription Services and Implementation Agreement - R18-062. The Parties amended the Existing Agreement on or about June 25, 2019 (Amendment No. 1), and on or about February 4, 2020 (Amendment No. 2) and on or about October 27, 2020 (Amendment No. 3), collectively attached hereto as Exhibit “A.” The Existing Agreement, Amendment No. 1, Amendment No. 2, and Amendment No. 3 are incorporated fully by reference (hereinafter collectively referred to as the “Agreement”).

WHEREAS, the Parties hereto desire to further amend the Agreement so that certain Masterworks software may be modified and/or configured for use by County, as provided by the Masterworks: Configuration Service Hours Proposal, attached hereto as Exhibit “B” and incorporated fully by reference; and

WHEREAS, pursuant to Section 4 of the Existing Agreement, the change order(s) and/or amendment(s) contemplated by the Parties must be contained in a written agreement.

NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Parties agree as follows:

AGREEMENT

1. Amendments to the Existing Agreement.

- 1.1. Section 3.2 of the Existing Agreement, including the modifications thereof in Amendment No. 1, Amendment No. 2, and Amendment No 3, is hereby amended by modifying subsection 3.2(b) to include the additional services:

3. Compensation and Payment.

3.1. County shall pay Aurigo the fees for the Additional Service Hours to configure the Aurigo Masterworks Professional Cloud Suite as listed in Section 1.1 of Exhibit B, in the amount of \$52,500.00. Payment of the fees for Masterworks software modifications concerning the Additional Service Hours to configure the Aurigo Masterworks Professional Cloud Suite will be made by County within thirty (30) days of receipt of invoice. Aurigo may submit invoice(s) electronically in a form acceptable to County via: apauditor@fortbendcountytexas.gov. If County disputes charges related to the invoice submitted by Aurigo, County shall notify Aurigo no later than twenty-one (21) days after the date County receives the invoice. If County does not dispute the invoice, then County shall pay each such approved invoice within thirty (30) calendar days. Interest resulting from late payments by County shall be governed by Chapter 2251, TEXAS GOVERNMENT CODE.

4. Date of Effectiveness; Limited Effect.

4.1. This Amendment No. 4 will become effective on the date of execution by County (the "Effective Date"). Except as expressly provided in this Amendment No. 4, all of the terms and provisions of the Agreement are and will remain in full force and effect and are hereby ratified and confirmed by the Parties. Without limiting the generality of the foregoing, the amendments contained herein will not be construed as an amendment to or waiver of any other provision of the Existing Agreement, Amendment No. 1, Amendment No. 2, and/or Amendment No. 3, or as a waiver of or consent to any further or future action on the part of either Party that would require the waiver or consent of the other Party. On and after the Effective Date, each reference in the Existing Agreement, Amendment No. 1, Amendment No. 2, and/or Amendment No 3, to "this Agreement," "the Agreement," "hereunder," "hereof," "herein," or words of like import will mean and be a reference to the Agreement as amended by this Amendment.

5. Human Trafficking.

6.1 Aurigo will provide services as described in Exhibit B concerning the provision of Additional Service Hours to configure the Aurigo Masterworks Professional Cloud Suite. The time for performance of the Scope of Services by Aurigo shall begin with receipt of the Notice to Proceed from County and end no later than December 31, 2023. Aurigo shall complete the tasks described in the Scope of Services without reasonable delay within this time or within such additional time as may be extended by the County.

(“Aurigo”), a company authorized to conduct business in the State of Texas, (each a “Party” and collectively the “Parties”).

WITNESSETH

WHEREAS, the Parties executed the AURIGO SOFTWARE SUBSCRIPTION SERVICES AND IMPLEMENTATION AGREEMENT – R18-062 on December 18, 2018 (the “Existing Agreement”), and available at Aurigo Software Subscription Services and Implementation Agreement - R18-062. The Parties amended the Existing Agreement on or about June 25, 2019 (Amendment No. 1), and on or about February 4, 2020 (Amendment No. 2), attached hereto as Exhibit “A.” The Existing Agreement, Amendment No. 1, and Amendment No. 2 are incorporated by reference (hereinafter collectively referred to as the “Agreement”).

3.1. Aurigo has provided a good faith deduction in the amount of \$9,000 on the final change order amount for the Masterworks software modifications.

3.2. County shall pay Aurigo the fees for the Masterworks software modifications listed in Section 3.3 of Exhibit B, in the amount of \$34,050. Payment of the fees for Masterworks software modifications will be made as provided by Section 3.6 and 3.7 of the Existing Agreement in conjunction with the frequency of payments as listed under the payment milestones for the Masterworks software modifications in Section 3.4 of Exhibit B.

7	Ticket #11149	FBC: Contract Line Item
8	Purchase Order workflows	Additional 4 PO workflows based on the PO type needs to be configured. Add a warning message while taking 'Issue PO' workflow action in all workflows to prompt the user to add an attachment. Existing PO and PO revision workflows will be modified to include two additional workflow stages (Stage 5 – Send for signature, Stage 6 – Send Signed Doc). This would allow to send the draft document back to the PO originator for signature. No changes will be carried out with the existing records. Revised workflows will be implemented on new records.

6.2 Aurigo will also provide a one-time Masterworks upgrade at no cost to County in accordance with page 10, Section 5 (Masterworks Upgrade) of Exhibit B. This one-time upgrade will be at no cost to the County.

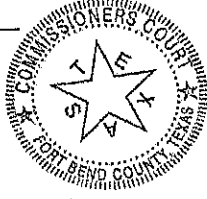

This discounted price is applicable for the remaining duration of the Agreement with County. Therefore, after execution of this Amendment, the Annual Subscription fees for years 3 – 5 will be \$331,863.00.
- 3.2. County shall pay Aurigo a prorated amount for the annual subscription fees for the additional Right of Way products of \$63,365.00 as provided by Section 3.6 and 3.7 of the Existing Agreement, upon execution of this Amendment.

County shall pay Aurigo the fees for implementation services listed under Section 2.2 of Exhibit B: Project Mobilization Fees of \$65,142; Configuration in the amount of \$48,856; System Testing & UAT in the amount of \$32,571; and End User Deployment & Go Live in the amount of \$16,286.00. 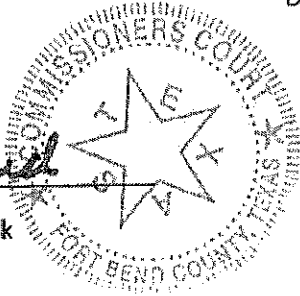



- 3.1. Aurigo has provided a 35% discount on the final change order amount for Software subscription fees, and a complete waiver for the one-time Implementation Services.
