Power of Attorney

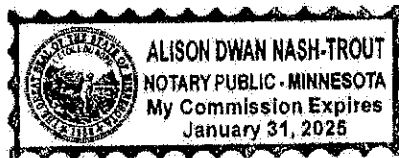


