KNOW ALL MEN BY THESE PRESENTS:

THAT WE, TACKLE CONSTRUCTION, INC. whose (address, phone) is P.O. Box 639, Brookshire, Texas 77423, (281) 391-3232 hereinafter called the Principal, and UNITED FIRE & CASUALTY COMPANY, a Corporation existing under and by virtue of the laws of the state of Iowa and authorized to do an indemnifying business in the State of Texas, and whose principal office is located at (name/address/phone) Joe Johnson, 455 East Medical Center Blvd., Suite 400, Webster, Texas 77598, whose officer residing in the State of Texas, authorized to accept service in all suits and actions brought within said state is UNITED FIRE & CASUALTY COMPANY and whose address is 118 Second Avenue SE, Cedar Rapids, IA 52401, hereinafter called the Surety, and held and firmly bound unto, KP George, County Judge of Fort Bend County, Texas, or his successors in office, in the full sum of Twelve Thousand Dollars and 00/100 Dollars (\$12,000.00) current, lawful money of the United States of America, to be paid to said KP George, County Judge of Fort Bend County, Texas, or his successors in office, to which payment well and truly to be made and done, we, the undersigned, bind ourselves and each of us, our heirs, executors, administrators, successors, assigns, and legal representatives, jointly and severally, by these presents.

AND WHEREAS, the principal desires to provide Fort Bend County with a performance bond covering all such cable, conduit and/or pole line activity, commercial driveway and median openings or modifications;
