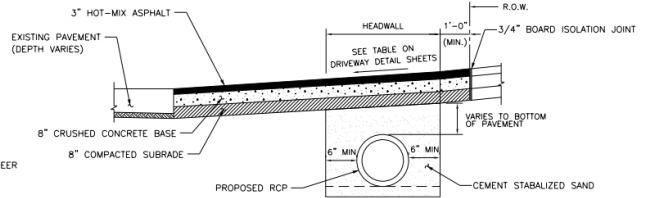


OPEN DITCH DRIVEWAY
*DITCH IS TO HAVE 4:1 SLOPE

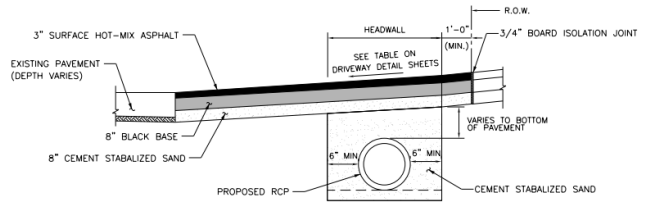

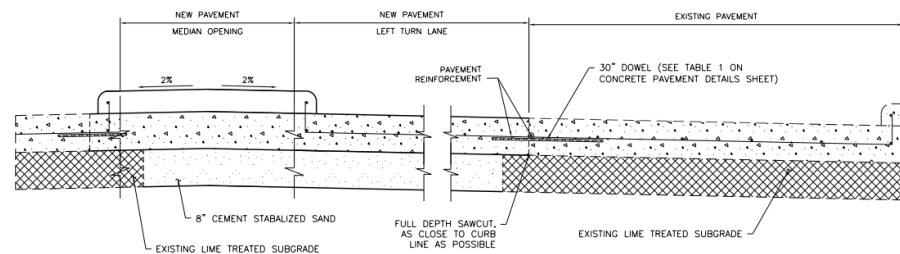
