DESCRIBE THE REASON FOR THE CHANGE ORDER AND WHAT IS BEING CHANGED. WHEN NECESSARY, INCLUDE EXCEPTIONS TO THIS AGREEMENT:

The subject project provides for the construction of the SH 99 southbound frontage road and ramp reversals from Westheimer Pkwy. to Cinco Ranch Blvd. including Continuously Reinforced Concrete Pavement, storm sewer, retaining walls, sound walls, and pavement markings in Fort Bend County.

The subject change order adds new Items of Work as follows:

New LINE NO. 0347, ITEM NO. 0496-6008 REMOVE STR (BOX CULVERT); 60.000 LF; \$51.91 per LF.

NEW LINE NO. 0623 Item No. 0662-6018 WK ZN PAV MRK NON-REMOV (W)(DBL ARW); 2.000 EA; \$196.19 EA.

Per Phase 1 of the traffic control plans, the existing 12-FT lanes at the intersection of the SH 99 southbound frontage road (SBFR) and Westheimer Pkwy are reduced to 11-FT to allow for the placement of low-profile concrete barrier (LPCB) for proposed pavement widening. During the traffic switch, the Contractor realized the existing double turn arrows conflicted with the temporary work zone pavement markings. To mitigate this, the Contractor had to eliminate the conflicting arrows and replace with temporary pavement markings. The item for the temporary double arrows was inadvertently omitted from the Contract.

Per the subject project, the existing open ditch from approx. STA. 2445+00 to 2455+00 (BL SBFR) will be replaced with a closed drainage in-line detention system. This system will replace an existing inlet and headwall connected by 6'x3' reinforced concrete box (RCB) and tie-in to the existing system at approx. STA 2444+48 with a 13'x7' junction box. The Contract contains items for removal of the headwall and inlet but inadvertently omitted the box culvert removal item.

This change order will introduce the inadvertently omitted items to the Contract for future use and provide compensation for those items placed and field measured to date. As noted, the design Engineer-of-Record is consultant TEDSI Infrastructure Group.

These revisions and future additions will be redlined on the project final as-built plan set.

The contractor has submitted the attached cost breakdown. New item of work 0496-6008 REMOVE STR (BOX CULVERT) is below the August 17, 2023 TxDOT statewide 3-month average low bid (ALB). New item of work 0662-6018 WK ZN PAV MRK NON-REMOV (W)(DBL ARW) is 54 percent over the September 11, 2023 ALB but that price is accepted due to the low quantity compared to the ALB. TxDOT has reviewed this submittal and deems it fair and reasonable for the work involved.

The revisions covered by this change order do not require revisions to the original environmental clearances or approval by the Texas Department of Licensing and Regulation.

This change order is estimated to result in an overrun in the amount fund associated with the project in the amount of \$3,506.98 This change order will not cause the accumulative amount of change orders to exceed 10 percent of the original contract amount and will not require District Engineer approval.


