## FIFTH AMENDMENT TO AGREEMENT FOR PROFESSIONAL ENVIRONMENTAL SERVICES

THIS FIFTH AMENDMENT ("FIFTH Amendment") is made and entered into by and between Fort Bend County ("County"), a body corporate and politic under the laws of the State of Texas, and SWCA, Inc. ("Contractor"), a company authorized to conduct business in the State of Texas (collectively referred to as the "parties").

WHEREAS, the parties have executed and accepted that certain Agreement for Professional Environmental Services, on or about January 12, 2021, pursuant to RFQ 20-109; and as amended on May 13, 2021, March 22, 2022, October 25, 2022, and July 11, 2023 (collectively the "Agreement"), and incorporated fully by reference for all purposes; and

WHEREAS, the County desires that Contractor provide additional Professional Environmental Services pursuant to RFQ 20-109; and

WHEREAS, the parties desire to extend the Time of Performance under the Agreement; and

**NOW, THEREFORE,** the parties do mutually agree as follows:

- 1. <u>Maximum Compensation</u>. The Maximum Compensation for the Scope of Services including reimbursable expenses shall be increased by **Thirty Thousand dollars and 00/100 (\$30,000.00)** bringing the new Total Maximum Compensation to **One Hundred Fifty Thousand dollars and 00/100 (\$150,000.00)**. In no case shall the amount paid by County for the Scope of Services exceed the Maximum Compensation without an approved Amendment.
- **Time of Performance**. This Fifth Amendment is effective upon execution by the County, and the Time of Performance under the Agreement is hereby extended to end no later than December 31, 2024.

Except as provided herein, all terms and conditions of the Agreement, including any addenda or amendments, not modified shall remain in full force and effect. If there is a conflict between this Fifth Amendment and the Agreement, the provisions of this Fifth Amendment shall prevail regarding the conflict.
