The **DEPARTMENT OF STATE HEALTH SERVICES** (DSHS or System Agency) and **FORT BEND COUNTY** (Grantee), Parties to that certain HIV Prevention Services Contract, effective January 1, 2020, and denominated DSHS Contract No. HHS000077800023 (the “Contract”), as amended, now want to further amend the Contract.

**WHEREAS**, the Parties want to extend the term of the Contract, and revise **ARTICLE III, DURATION**, of the Contract Signature Document consistent with Request for Applications No. HHS0000778.

**NOW, THEREFORE**, the Parties agree as follows:

1. **ARTICLE III, DURATION**, of the Contract Signature Document is hereby amended to extend the termination date to December 31, 2024, unless terminated sooner, consistent with Request for Applications No. HHS0000778.
2. This Amendment shall be effective upon the signature date of the latter of the Parties to sign this agreement.
3. Except as amended and modified by this Amendment, all terms and conditions of the Contract, as previously amended, shall remain in full force and effect.
4. Any further revisions to the Contract shall be by written agreement of the Parties.
