The **DEPARTMENT OF STATE HEALTH SERVICES** (DSHS or System Agency) and **FORT BEND COUNTY** (Grantee), Parties to that certain HIV Prevention Services Contract, effective January 1, 2020, and denominated DSHS Contract No. HHS000077800023 (the "Contract"), as amended, now want to further amend the Contract.
