

#### **GUEST REGISTRATION**

Guests (21 years of age and older) will require a Guest Registration to attend all three events: Opening Reception, General Session & Opening Keynote, and Conference Finale & Closing Keynote. Only full conference attendees may purchase a Guest Registration (limit of one) for US \$350. A guest is defined as a spouse, significant other, family member, or friend whose occupation is unrelated to the risk and insurance management profession. A co-worker or associate within the profession is not eligible for guest registration. Guest registration includes RIMS shuttle bus transportation between a RIMS hotel and the San Diego Convention Center (SDCC). Guest registration does not include access to educational sessions, and thus guests are not eligible for continuing education credits, nor does the guest badge permit access to the RISKWORLD Marketplace. Please note: guests will receive different badges from other participants. It is against RIMS policy to register someone in the guest category who does not meet the aforementioned guest criteria.
