The purpose of this award is for Bus Support Equipment, Misc Software, Software Maintenance, Capital Items, Vehicle Inspections, Park & Ride Lot License, 3rd party Contracting, Education and Training, Mobility Mgmt, Operating Assistance, Program Support, and Planning using FY2022 5307 funding in the amount of \$5,650,000 and TDCs in the amount of \$1,535,549 approved by HGAC on 7/28/2023.
