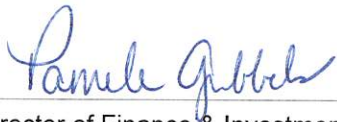

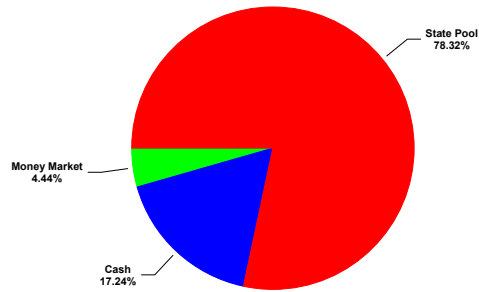

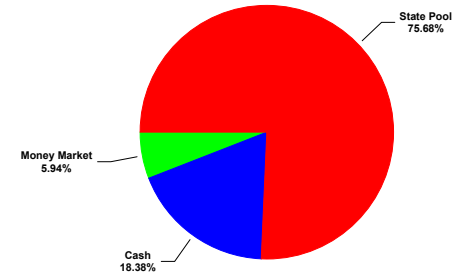

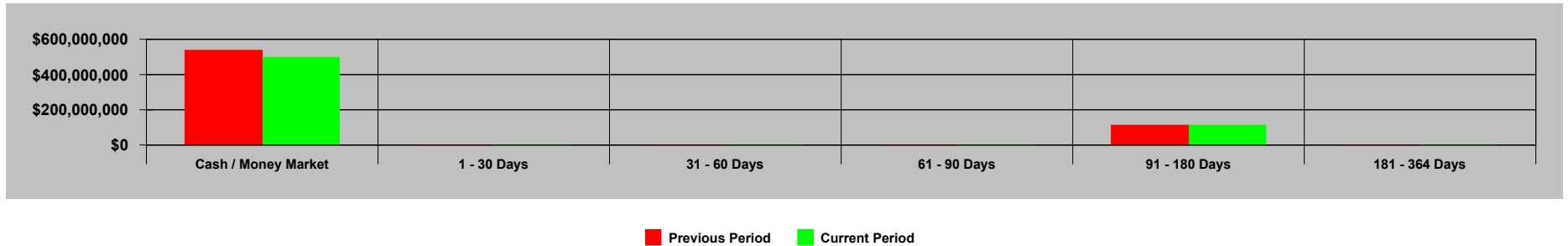
Portfolio Composition - 09/30/23



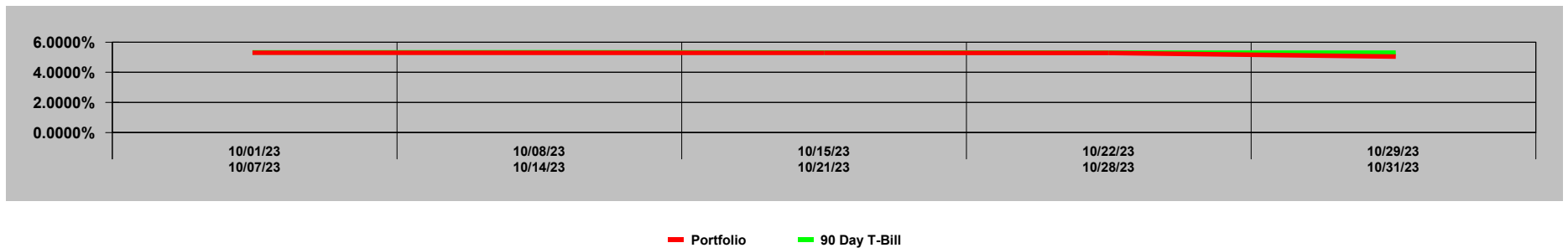
Portfolio Composition - 10/31/23
