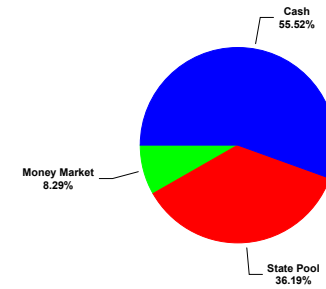

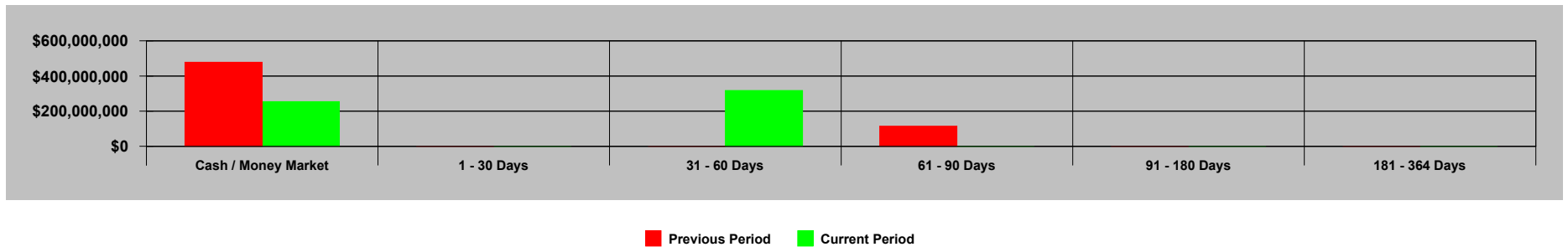
Portfolio Composition - 11/30/23



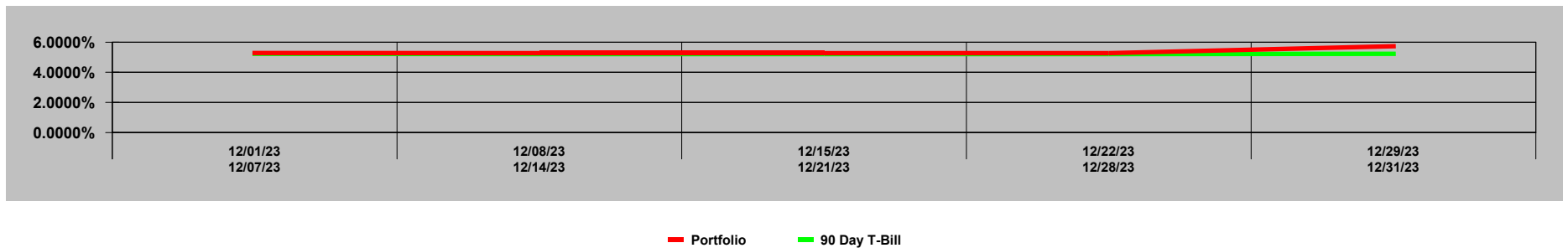
Portfolio Composition - 12/31/23
