## AMENDMENT

This amendment ("Amendment") is effective as of the date of signature of the last party to sign as indicated below ("Amendment Effective Date"), by and between Tyler Technologies, Inc. with offices at 5101 Tennyson Parkway, Plano, Texas 75024 ("Tyler") and Fort Bend County, Texas, a political subdivision of the State of Texas ("Client").

WHEREAS, Tyler and the Client are parties to a Software as a Service Agreement dated December 15, 2020 ("Agreement"); and

WHEREAS, Tyler and Client desire to amend the terms of the Agreement as provided herein.

NOW THEREFORE, in consideration of the mutual promises hereinafter contained, Tyler and the Client agree as follows:

1. As of the first day of the first month following the Amendment Effective Date, the estimated annual summons amount included with the Jury Summons service under the Agreement shall increase to 185,000 documents per year, and accordingly, the price per summons shall decrease from \$0.50 to \$0.49. Fees for the Jury Summons service shall continue to be invoiced monthly in arrears in accordance with the terms of the Agreement.
2. This Amendment shall be governed by and construed in accordance with the terms and conditions of the Agreement. Except as expressly indicated in this Amendment, all other terms and conditions of the Agreement shall remain in full force and effect.
