Dear Judge and Commissioners:

The Board of Directors of the Fort Bend Grand Parkway Toll Road Authority (the "Authority") reviewed the matter described below at its regular meeting held on March 18, 2024, and makes the following recommendation to Commissioners Court:

1. Board hereby (a) reports to Fort Bend County Commissioners Court the existence of an unpermitted commercial driveway near Mason Road and the Grand Parkway which was constructed in violation of applicable County regulations and (b) due to safety concerns with the location of the driveway requests that Commissioners Court take action directing the Authority to coordinate with County Engineer and other County Departments, as necessary and appropriate, to enforcement compliance with the applicable County regulations, including possible removal of unpermitted driveway.

A copy of the Board resolution and related materials are included with this letter. Please place the foregoing item for consideration by Commissioners Court on the agenda for the meeting scheduled on March 26, 2024.
