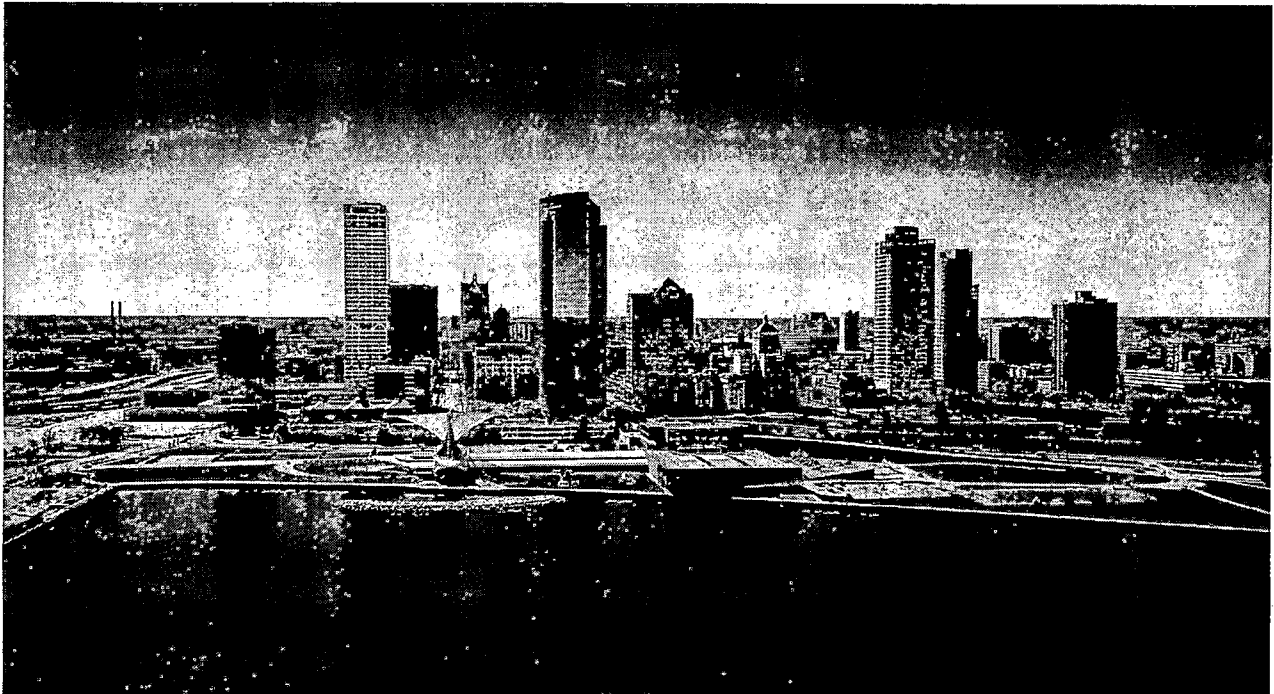

RESERVATIONS: You can make reservations by calling the above number. When calling, please advise you are with the National Association of Extradition Officials to ensure you receive the group rate. An online booking link is also available at:

Reservations must be finalized no later than **Monday, May 3, 2024**, to receive the current government prevailing per diem rate of \$129.00 plus 15.5% tax. A first night's deposit must be received with the reservation. Rooms are based on single or double occupancy, per night. Check in is after 4:00 pm and check out is by 11:00 am. The GSA rate will be honored 1 day prior and 1 day post, based on hotel availability. Individual hotel rooms must be cancelled seventy two (72) hours prior to check in, after which a \$75 cancellation fee shall be assessed.

SMOKING/VAPING POLICY: Smoking or vaping is only allowed in designated gaming areas of the casino. Smoking and vaping are prohibited in all areas inside the hotel, including guest rooms and meeting spaces. Any guest smoking or vaping in their guest room will be assessed a daily fee of \$250.

HOTEL PARKING: Valet parking is open 24/7 for hotel & ~~Diamond~~ guests. Free self-parking is available in a parking garage. Hotel guests are encouraged to drop off luggage at the hotel entrance bell service area prior to parking.

TRANSPORTATION OPTIONS FROM/TO AIRPORT: The hotel is 9 miles from the Milwaukee International Airport (MKE) Uber, Lyft and taxis are approximately \$25-35 one way depending on the time of day. *[Note – All fares subject to change.]*

IF YOU ARE AN ARMED OFFICER, PLEASE NOTE: You must have your credentials to carry your weapon inside the casino and hotel; there are safes in the hotel guest rooms. If you do not have your credentials, you can not bring your weapon into either the casino or hotel.
