ORDER OF FORT BEND COUNTY COMMISSIONER'S COURT FOLLOWING AN AFFIRMATIVE VOTE OF THE MAJORITY OF THE VOTES CAST IN AN ELECTION HELD ON MAY 4, 2024 TO CREATE FORT BEND COUNTY EMERGENCY SERVICES DISTRICT NO. 10 AND AUTHORIZE THE LEVY BY SAID DISTRICT OF A TAX NOT TO EXCEED THE LIMITS OF ARTICLE III, SECTION 48-e OF THE TEXAS CONSTITUTION, AND PURSUANT TO SECTION 775.019 AND OTHER RELEVANT PROVISIONS OF CHAPTER 775, TEXAS HEALTH & SAFETY CODE

WHEREAS, at an election held on the 4th day of May, 2024 in that part of Fort Bend County, Texas described with the applicable boundaries in Exhibit "A", attached hereto and incorporated herein, there was submitted to the qualified voters in said territory the following proposition of whether there should be created in the described territory Fort Bend County Emergency Services District No. 10, under state law, with the authority to levy a tax not to exceed ten cents per one hundred dollar valuation:

"CONFIRMATION OF THE CREATION OF FORT BEND COUNTY EMERGENCY SERVICES DISTRICT NO. 10 AND THE LEVY BY SAID DISTRICT OF A TAX NOT TO EXCEED TEN (10) CENTS ON THE ONE HUNDRED DOLLAR (\$100.00) VALUATION." and

THEREFORE, BE IT ORDERED, ADJUDGED, AND DECREED BY THE COMMISSIONERS COURT OF FORT BEND COUNTY, TEXAS THAT FORT BEND COUNTY EMERGENCY SERVICES DISTRICT NO. 10 HAS BEEN DULY AND LEGALLY FORMED WITHIN THE GEOGRAPHIC AREA DESCRIBED IN EXHIBIT "A", ATTACHED HERETO AND INCORPORATED HEREIN, PURSUANT TO ARTICLE III, SECTION 48-e, OF THE TEXAS CONSTITUTION AS PROPOSED BY S.J.R. NO. 27, ACTS OF THE 70TH LEGISLATURE, REGULAR SESSION 1987, AND ADOPTED BY THE VOTERS AT AN ELECTION HELD NOVEMBER 3, 1987, AND HAS THE POWERS VESTED BY LAW IN THE DISTRICT INCLUDING, BUT NOT LIMITED TO, THE AUTHORITY TO LEVY A TAX NOT TO EXCEED TEN CENTS PER ONE HUNDRED DOLLAR VALUATION.
