## FIRST AMENDMENT TO RENEWAL OF AGREEMENT FOR FFP FUNDING BETWEEN JUSTICE BENEFITS, INC. AND FORT BEND COUNTY

THIS FIRST AMENDMENT ("Amendment") is made and entered into by and between FORT BEND COUNTY, (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and JUSTICE BENEFITS, INC. as the general partner of JBI, LTD., (hereinafter referred to as "JBI" or "Contractor"), a Texas limited partnership.

WHEREAS, the parties have executed and accepted that certain *Agreement For FFP Funding Between Justice Benefits, Inc. And Fort Bend County* (the "Agreement,") on or about June 23, 2020, as renewed by document executed on August 3, 2021, August 32, 2022, and June 27, 2023 (hereinafter collectively as the "Agreement") which is incorporated by reference as if set forth herein verbatim; and

WHEREAS, by execution of this Amendment, the Parties desire to amend the Agreement to increase the Total Maximum Compensation for completion of such services and to otherwise ratify and confirm all the terms and conditions as set forth herein;

WHEREAS, the following changes are incorporated as if a part of the original Agreement by reference in the same as if fully set forth verbatim therein;

NOW THEREFORE, in consideration of the foregoing, the Parties do mutually agree that the Agreement between the Parties is hereby amended as follows:

- 1. **Scope of Services.** County shall pay Contractor an additional Seven Thousand and 00/100 dollars (\$7,000.00) for the performance and completion of services.
- 2. **Limit of Appropriation.** Contractor understands and agrees that the Maximum Compensation payable to Contractor for Services rendered under this Agreement is hereby increased to an amount not to exceed Ninety-Thousand and 00/100 dollars (\$97,000.00), authorized as follows:

\$90,000.00	under the Agreement
\$7,000.00	under this Amendment
TOTAL	\$97,000.00

In no event shall the amount paid by County under this Agreement exceed the Maximum Compensation without a County approved change order. Contractor clearly understands and agrees, such understanding and

agreement being the absolute essence of this Agreement, that County shall have available the total maximum sum of Ninety-Thousand and 00/100 dollars (\$97,000.00) specifically allocated to fully discharge any and all liabilities County may incur under the Agreement.

Contractor does further understand and agree, said understanding and agreement also being of the absolute essence of the Agreement, that the total Maximum Compensation that Contractor may become entitled to and the total maximum sum that County may become liable to pay to Contractor under the Agreement shall not under any conditions, circumstances, or interpretations thereof exceed Ninety-Thousand and 00/100 dollars (\$97,000.00).

- 3. **Recitals.** The recitals set forth above are incorporated herein by reference and made a part of the Agreement.
- 4. Modifications and Conflict. Except as provided herein, all terms and conditions of the Agreement, including any addenda or amendments, not modified herein shall remain in full force and effect for the term of Agreement. If there is a conflict between this Amendment and the Agreement for FFP Funding Between Justice Benefits, Inc. and Fort Bend County, the provisions of this Amendment shall prevail with regard to the conflict.
