Dear Judge and Commissioners:

The Board of Directors of the Fort Bend County Toll Road Authority (the "Authority") reviewed the following agenda items at their regular meeting held on May 20, 2024, and makes the following recommendation to Commissioners Court:

1. Approve Resolution approving recommended alignment for Segment B-4 of the Fort Bend Parkway from Sienna Levee to FM 2759 (crossing the Brazos River), authorizing the Authority to proceed with right-of-way acquisition and utility relocation, and approving certain other matters relating thereto.
2. Approve Resolution approving and accepting recommended alignment for a portion of Segment C of the Fort Bend Parkway from FM 2759 to Rabbs Prairie Road, authorizing the Authority to proceed with right-of-way acquisition and utility relocation, and approving certain other matters relating thereto.
3. Ratify and confirm agreement between the Authority and Harper Brothers Construction LLC for construction of the Fort Bend Westpark Tollway Extension from Bois D'Arc Lane/Charger Way to West of Spring Green/FM 723 (Project 101-1032).
