**ORDER OF FORT BEND COUNTY COMMISSIONER'S COURT APPOINTING THE INITIAL BOARD OF COMMISSIONERS OF FORT BEND COUNTY EMERGENCY SERVICES DISTRICT NO. 10 FOLLOWING AN AFFIRMATIVE VOTE OF THE MAJORITY OF THE VOTES CAST IN AN ELECTION HELD ON MAY 4, 2024 TO CREATE FORT BEND COUNTY EMERGENCY SERVICES DISTRICT NO. 10, PURSUANT TO CHAPTER 775, TEXAS HEALTH & SAFETY CODE**

**WHEREAS**, at an election held on the 4th day of May, 2024, there was submitted to the qualified voters in the territory of the proposed Fort Bend County Emergency Services District No. 10, the proposition of whether there should be created Fort Bend County Emergency Services District No. 10 in the territory, under state law, with the authority to levy a tax not to exceed ten cents per one hundred dollar valuation; and

**WHEREAS**, the formation of Fort Bend County Emergency Services District No. 10, and the imposition of a tax not to exceed Ten Cents on the One Hundred Dollar valuation, received the affirmative vote of the majority of the votes cast at the election, as provided by law; and

**WHEREAS**, the Commissioner's Court conducted the canvass and affirming the election results of the election to create Fort Bend County Emergency Services District No. 10, under state law, with the authority to levy a tax not to exceed ten cents per one hundred dollar valuation, and entered an Order regarding same dated May14, 2024; and

**WHEREAS**, pursuant to Section775.034, Texas Health and Safety Code, following the election, the Commissioner's Court shall appoint the initial Board of Commissioners of Fort Bend County Emergency Services District No. 10, consisting of five members each to serve an initial term of office until January 1, 2025; and

**WHEREAS**, pursuant to Section 775.034, Texas Health and Safety Code, to serve as a commissioner of Fort Bend County Emergency Services District No. 10, a person must:

be at least 18 years of age; and

be a resident citizen of the state; and

either (i) be a qualified voter within areas served by the district, or

(ii) be the owner of land subject to taxation in the district; and

**WHEREAS**, each of the following named persons satisfy the prerequisites to qualify to serve as a commissioner of Fort Bend County Emergency Services District No. 10,

**THEREFORE, BE IT ORDERED, ADJUDGED, AND DECREED BY THE COMMISSIONERS COURT OF FORT BEND COUNTY, TEXAS, THAT THE FOLLOWING NAMED PERSONS ARE HEREBY APPOINTED TO SERVE AS THE INITIAL BOARD OF COMMISSIONERS OF FORT BEND COUNTY EMERGENCY SERVICES DISTRICT NO. 10:**
