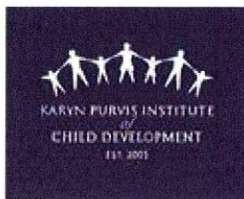

Welcome to the Sept./Oct. 2024 TBRI® Practitioner Training in Seattle, Washington. This notification contains important information — please take time to review the entire document.

Verification of Your Account

Please be sure your account is verified by returning to the registration page and logging in. Phase One of the Training

TBRI® Practitioner Training consists of two phases. Phase Two is the “face-to-face” portion, and takes place in Sept./ Oct. in Seattle, Washington. Phase One is the self-paced “online” portion, and it takes place during the ten weeks prior to the face-to-face, onsite portion. Phase One must be completed prior to your participation in Phase Two. The Phase One-Phase Two sequence is essential to the instructional design of the training, and we make no exceptions. Phase One consists of the following, all of which are required:

1. Verification of your account;
2. Ten weeks of online coursework;
3. A scheduled interpersonal interview;
4. Scheduled financial payments (registration fee is \$3,500).

Important Dates and Deadlines

The integrity of the training depends on your meeting the deadlines, and taking the assignments seriously. We are only able to admit less than one-half of the applicants for the training — if you fail to take this training seriously, you will be taking the place of a person who would have taken the training seriously, which in effect limits the impact of our training. So, please adhere to the following deadlines.

June 24	Deposit of \$500 is due
July 2	Balance in full is required. Registration fee is \$3,500
July 9	Phase One begins
July 5	Instructions to schedule your interpersonal interview emailed to you
July 30	Please complete at least three online modules to stay caught up
July 15	Interpersonal interviews begin
September 13	Interpersonal interviews must be completed
September 20	Phase One ends - online modules must be completed.

Additional Information:

- Phase I opens contingent upon satisfactory financial status.
- Withdrawing from the training before July 23, 2024 will allow a refund of payments, less the \$500 deposit.
- Exiting training after July 23, 2024 includes a 50% forfeiture of your total payments, with the exception of scholarship recipients who are not eligible for a refund of their deposit.
