Dear Judge and Commissioners:

The Board of Directors of the Fort Bend County Toll Road Authority (the "Authority") reviewed the following agenda items at their regular meeting held on July 15, 2024, and makes the following recommendation to Commissioners Court:

1. Ratify and confirm Authority resolution requesting appropriate approvals to temporarily lower the posted 60 mph speed limit on the main lanes of the Fort Bend Parkway Carey Chase southbound entrance ramp to 55 mph during construction of the project, with the posted speed limit of 60 mph resuming after construction is complete.
