





**AMENDED STAGING AREA SITE AGREEMENT**

This Amended Agreement is made and entered into between Fort Bend County, a body corporate and politic, acting herein by and through its Commissioner's Court ("County") and CenterPoint Energy, Houston Electric (CenterPoint) for the purpose of providing the Fort Bend County Fairgrounds as a staging area to CenterPoint, it's Contractors, Agents and Volunteers, during emergency/disaster electrical restoration. This Amended Agreement supercedes for all purposes the current "Staging Area Site Agreement" effective beginning July 16, 2007 and ending July 15, 2012.

Pursuant to this Amended Agreement, Fort Bend County, grants CenterPoint the non-exclusive right to use the any and all Fort Bend County Fairground land or facilities as a staging area in the event of an emergency except the following:

- 1) the Arena; and
- 2) the area commonly known as the "Barbeque Cook-off" area as designated on the Attached Exhibit "A" as the parcel of land shaded with an orange highlighter and marked with the Letter "A." (Exhibit "A" is hereby incorporated by reference for all purposes.)

Both parties agree that during an emergency requiring the use of the Fort Bend County Fairgrounds, the Director of the Fort Bend County Office of Emergency Management ("Director"), or his/her designee, retains the authority to resolve concurrent claims by multiple parties to the use of the property described above. This authority includes the authority to assign to one party the exclusive use of any portion of the property as the Director or his/her designee deems necessary.

CenterPoint shall exercise reasonable care in the conduct of its activities in such facilities and further agrees to replace or reimburse for any supplies that may be used by CenterPoint in the conduct of its relief activities in said disaster. CenterPoint agrees to fully reimburse County for any and all damage to the facilities caused or occasioned by the use of said facilities by CenterPoint, its Contractors, Agents and Volunteers under the terms of this Agreement.


CenterPoint agrees to accept the facilities of the Fort Bend County Fairgrounds including the buildings thereon, in the condition in which they exist when the request for use is made, without any representations, statements, warranties, express or implied, in respect to their condition, for the use of occupation that may be made of the facility by CenterPoint, and in no event shall County be liable for any defects therein. CenterPoint also agrees to indemnify and hold harmless, County, its Agents and Employees from any and all claims, damages, liabilities or expenses arising out of the CenterPoint use of the facility including the buildings and any act of omission or negligence of CenterPoint, its Agents, Invitees or Employees. CenterPoint is self insured for the first \$2M or any claim per the attached letter.

Both may terminate this Agreement at any time by providing thirty (30) days written notice of the intent to terminate the Agreement.

This Agreement will be effective beginning July 16, 2007 and ending on July 15, 2012.
