RE: Resolution approving recommended changes to Toll Rate Order, including new toll schedule for additional gantries, and request to submit recommended changes to Commissioners Court for further action

The Order thus adopted follows:

THIRD SUPPLEMENTAL ORDER SUPPLEMENTING AND CLARIFYING TOLL RATE ORDER AND ADDING ADDITIONAL GANTRIES TO THE TOLL RATE SCHEDULE FOR THE FORT BEND PARKWAY AND WESTPARK TOLLWAY

BACKGROUND

The Fort Bend County Toll Road Authority ("Authority") is operating the Fort Bend Parkway and Westpark Tollway Toll Roads on behalf of Fort Bend County ("County"); and

The Authority desires to supplement and clarify policies and procedures relating to toll collection and violation enforcement on the Fort Bend Parkway and Westpark Tollway, as provided herein, and to establish to a toll rate schedule for the Sienna Ranch Road Ramp Plaza on the Fort Bend Parkway and the Grand Parkway Direct Connector Plaza on the Westpark Tollway as shown on <u>Schedule 1</u>, attached hereto;

NOW, THEREFORE, IT IS ORDERED BY THE COMMISSIONERS COURT OF FORT BEND COUNTY, TEXAS THAT:

The Amended and Restated Order Establishing a Toll Rate Schedule for the Fort Bend County Toll Road System; Prohibiting the Operation of a Motor Vehicle on the Road System After Failure to Pay Required Toll or Charge; Establishing an Administrative Adjudication Hearing Procedure for Violation of this Order; Containing Other Provisions Relating to the Subject dated April 6, 2021, the Supplemental Order Establishing a Toll Rate Schedule for the Fort Bend Parkway and Westpark Tollway dated January 11, 2022, and the Second Supplemental Order Supplementing and Clarifying Toll Violation Enforcement Procedures dated September 27, 2022 (collectively, the "Rate Order"), are hereby further supplemented and amended as follows:

<u>SECTION 1</u>. The following replaces the first paragraph of Section 3 of the Rate Order:

"Section 3. Toll Rates; Toll Payment Required.

Unless otherwise exempt by State law or the County's Non-Revenue and Discount Use Policy, all persons operating vehicles on a County Toll Road System are required to pay tolls at designated toll plazas thru the use of a prefunded toll account. The required toll at each toll plaza of the County Toll Road System is established as those tolls and charges shown on **Exhibit A**."

SECTION 2. The following replaces Section 4 of the Rate Order:

"Section 4. Failure to Pay Toll.

Unless otherwise exempt, no person may operate a motor vehicle, or cause or allow the operation of a motor vehicle on the County Toll Road System without a pre-funded toll account."

SECTION 3. The following replaces Section 5 of the Rate Order:

"Section 5. Toll Violation Notice and Opportunity to Pay Required Toll, Charge, and Fee.

If a person uses a Fort Bend County Toll Road in violation of this Order, the County, the Authority or the appropriate designee shall attempt to collect the required toll as provided in this Section 5, plus the associated fees and charges shown in **Exhibit B**.

First, the County, the Authority or the appropriate designee shall provide to the registered owner of the vehicle a written Courtesy Notice of the unpaid toll.

Second, if the registered owner fails to pay the full amount due as shown on the Courtesy Notice within thirty (30) days of the date of the-Courtesy Notice, or has received 5 Courtesy Notices in 365 calendar days that remain unpaid, all future violation notices within the 365 calendar day period will bypass the Courtesy Notice, the County, the Authority or the appropriate designee shall provide to the registered owner of the vehicle a written Toll Violation Notice (TVN).

Third, if the registered owner fails to pay the full amount due as shown on the TVN within thirty (30) days of the date of the TVN, the County, the Authority or the appropriate designee shall provide, to the registered owner of the vehicle, a written Final Toll Violation Notice (FTVN)."

<u>SECTION 4.</u> Exhibit A to the Rate Order is amended by adding the toll rate schedule for the Sienna Ranch Road Ramp Plaza on the Fort Bend Parkway and the Grand Parkway Direct Connector Plaza on the Westpark Tollway as shown on <u>Schedule 1</u>, attached hereto.

SECTION 5. **Exhibit B** to the Rate Order is amended by striking "Initial Notice" and replacing it with "Courtesy Notice" and adding the following to the end of **Exhibit B**:
