**FORT BEND COUNTY EXCESSIVE FORCE POLICY**

Fort Bend County hereby adopts and agrees to enforce, to the extent authorized by state law, a policy prohibiting the use of excessive force by law enforcement agencies against any individuals engaged in non-violent civil rights demonstrations in the county. Also, Fort Bend County hereby adopts a policy of enforcing applicable State and local laws against physically barring entrance to or exit from a facility or location which is the subject of a non-violent civil rights demonstration within the county.
