SECOND AMENDMENT TO AGREEMENT BETWEEN JAIL CHAPLAINCY MINISTRIES, INC. AND THE FORT BEND COUNTY SHERIFF FOR JAIL CHAPLAINCY SERVICES

THIS AGREEMENT is made and entered into by and between the duly elected Fort Bend County Sheriff, (hereinafter "Sheriff"), and JAIL CHAPLAINCY MINISTRIES, INC. (hereinafter "Contractor"), a non-profit corporation organized under the laws of the State of Texas.

WITNESSETH

WHEREAS, the parties executed and accepted the Agreement on or about November 14, 2022 and as amended on October 23, 2023 (the "Agreement"), such Agreement being incorporated as part of this Amendment by reference as if written herein verbatim;

WHEREAS, the parties desire to amend the Agreement to extend the time of performance and as a result increase the compensation and payment as will be described in greater detail in this Second Amendment.

NOW, THEREFORE, the parties do mutually agree to Amend the Agreement to include the following:

AGREEMENT

1. Time of Performance

The time for performance of the Scope of Services by Contractor shall begin upon receipt of the Notice to Proceed from The Sheriff and end no later than December 31, 2025. Contractor shall complete the tasks described in the Scope of Services within this time or within such additional time as may be extended by the Sheriff.

2. Compensation and Payment

The Maximum Compensation for the performance of Services within the Scope of Services in the Agreement is hereby increased, for FY2025, to eleven thousand, three hundred seventy-eight dollars and 00/100 (\$11,378.00) per month, for a total maximum compensation, under this Second Amendment, of one hundred thirty-six thousand, five hundred thirty-six dollars and 00/100 (\$136,536.00). In no case shall the amount paid by the Sheriff under this Second Amendment exceed the Maximum Compensation without an approved change order.

3. Modifications and Conflict

Except as modified herein, the Agreement shall remain in full force and effect and has not been otherwise modified or amended. If there is a conflict among documents that make up the Agreement, this Amendment shall prevail with regard to the conflict.
