Scope of Services

Activity 1:

Facilitating cross-sector collaboration between public health, and substance abuse prevention programs as well as education, community engagement, and building community partnerships since this will be critical to designing and implementing effective opioid use disorder prevention efforts

Supporting data collection and research, which is widely recognized as a core abatement strategy

Drug Testing Cost Proposal

The drug testing costs for the Felony and Misdemeanor treatment courts for a two-year funding will be \$40,000

Drug Testing Cost Per Year.

Urinalysis Testing: \$15,500

Hair Testing Cost \$4,500

Recovery Coach

A recovery coach supports individuals in specialty courts, such as drug or veteran's courts, by providing peer support and guidance based on shared experiences.

A certified community supervision and corrections officer who is trained and certified to conduct pre and post Full Felony Texas Risk Assessments (TRAS) and other validated assessments, specifically the Texas Christian University Drug Screen 5 (TCU Drug Screen 5, the Adult Substance Subtle Screening Inventory–4 (SASSI), and the Computerized Assessment Referrall System (CARS) to assess the risks, needs and identify both criminogenic nees and barriers to programming of clients involved in the criminal justice system suffering from opioid–related addiction.

TOTAL TWO YEAR PROGRAM COSTS: \$187,240.98
