Hello Fort Bend County,

In reference to Bid 22-098, please see below for the price increase in Dibrom in 2024. Based on the 4+ drum quantity, the price increased 5% from \$7,928.70 per drum in 2023 to \$8,325.30 per drum in 2024. There are 30 gallons per drum. To break this down further, at an application rate of 0.75 ounces per acre, the chemical cost per acre increased by \$0.08.

For this reason, we would like to request that our price per acre, which is currently at \$2.44/acre to be amended to \$2.52/acre to reflect this increase in chemical cost.

Please be advised that continuing regulatory costs associated with re-registration of the active ingredients of these products and the increased logistics costs for delivery and disposal has resulted in price increases for products distributed by ADAPCO.

As well, we are experiencing significant price increase in raw materials for Dibrom and Trumpet plus Nuvan and Avesta items. These input costs have resulted in price increases of approximately 5% for these products in 2024.
