**FOURTH AMENDMENT TO AGREEMENT FOR PROFESSIONAL ENVIRONMENTAL SERVICES**

THIS FOURTH AMENDEMENT ("Fourth Amendment") is made and entered into by and between Fort Bend County, ("County"), a body corporate and politic under the laws of the State of Texas, and MPACT Strategic Consulting, LLC ("Contractor"), a company authorized to conduct business in the State of Texas.

W I T N E S S E T H

WHEREAS, the parties have executed and accepted that certain Agreement for environmental review and consulting services as required for various County improvement projects pursuant to SOQ 20-109, on or about January 12, 2021; and as amended on or about October 25, 2022 (the "Amendment"), and as amended on or about July 11, 2023 (the "Second Amendment"), and as amended on or about December 19, 2023 (the "Third Amendment") (collectively referred to as the "Agreement"), and incorporated fully by reference for all purposes; and

WHEREAS, the County desires that Contractor provide additional Professional Environmental Services pursuant to SOQ 20-109; and

WHEREAS, the parties desire to extend the Time of Performance under the Agreement; and

NOW, THEREFORE, in consideration of the mutual covenants and conditions set forth in the Agreement and this Amendment, the parties agree as follows:

1. **Maximum Compensation.** The Maximum Compensation for the Scope of Services shall be increased by **Fourteen Thousand dollars and 00/100 (\$14,000.00)** bringing the new Total Maximum Compensation to **Ninety-Nine Thousand dollars and 00/100 (\$99,000.00)**. In no case shall the amount paid by County for the Scope of Services exceed this Maximum Compensation without an approved amendment.
2. **Time of Performance.** This Fourth Amendment is effective upon execution by the County, and the Time of Performance under the Agreement is hereby extended to end no later than September 25, 2025.

Except as provided herein, all terms and conditions of the Agreement, including any addenda or amendments, not modified shall remain in full force and effect. If there is a conflict between this Third Amendment and the Agreement, the provisions of this Third Amendment shall prevail regarding the conflict.
