AMENDMENT TO AGREEMENT FOR ANIMAL CONTROL A/C TRUCK BODY

THIS AMENDMENT TO AGREEMENT FOR ANIMAL CONTROL A/C TRUCK BODY (the "Amendment"), is made and entered into by and between Fort Bend County (hereinafter "County"), a body corporate and politic under the laws of the State of Texas, and Hartstra Manufacturing, LLC. (hereinafter "Contractor"), a company authorized to conduct business in the State of Texas.

WHEREAS, the parties executed and accepted that certain Agreement for Animal Control A/C Truck Body on January 9, 2024 (hereinafter "Agreement") pursuant to RFP 23-069; and

WHEREAS, the parties desire to further amend the Agreement for additional services to be provided, to extend the contract time of performance, and increase the total Maximum Compensation under the Agreement for the completion of such additional services.

NOW, THEREFORE, the parties do mutually agree as follows:

1. County shall pay Contractor an additional amount not to exceed thirty-eight thousand, eight hundred eighty-seven and 00/100 (\$38,887.00) to perform the additional Services, as described in Contractor's Quote dated July 25, 2024, attached hereto as Exhibit "A-1" and incorporated herein for all purposes.
2. The Maximum Compensation payable to Contractor for all Services rendered is hereby increased to an amount not to exceed one hundred forty-five thousand dollars, eight hundred fifty-eight and 00/100 (\$145,858.00), authorized as follows:
 \$ 106,971.00 under the Agreement; and
 \$ 38,887.00 under this Amendment.
3. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without an agreement executed by the parties.
4. The Term of this Agreement for the performance of services is extended and shall terminate on July 1, 2025, unless terminated sooner in accordance with the Agreement.

5. BY ACCEPTANCE OF AGREEMENT, CONTRACTOR ACKNOWLEDGES THAT THE COUNTY IS OPPOSED TO HUMAN TRAFFICKING AND THAT NO COUNTY FUNDS WILL BE USED IN SUPPORT OF SERVICES OR ACTIVITIES THAT VIOLATE HUMAN TRAFFICKING LAWS.

Except as provided herein, all terms and conditions of the Agreement shall remain unchanged.


