Dear Honorable Judge KP George:

As Manager of Folklore Development, LLC, I respectfully request that Fort Bend County consider sponsoring the project referenced above. The Texas Department of Transportation ("TxDOT") will only consider a permit for the street tie-in of the proposed Milo Farm Lane at Farm Road 360 if you agree to sponsor the work.

This proposed public street "Milo Farms Lane" will tie-in to Farm Road 360 following TxDOT design standards. It will also provide combined access to the Plainview Subdivision and to our proposed development of our 26.76-acre tract for Section 1 of Milo Farms Single-Family development with a proposed 87 homes.

We have submitted the driveway permit application to TxDOT for the proposed Milo Farms Lane tie-in to Farm to Market Road 360. This sponsorship is one of the few remaining items needed to obtain the permit.

Folklore Development, LLC will fund the cost of the construction. There will be no expense to Fort Bend County. The attached construction plan drawings produced by Canopy Engineering, LLC, were prepared in accordance with TxDOT's street tie-in permit requirements.
