The African American Experience at Bates Allen Park is located in the city of Kendleton, TX, founded in 1865 by freed slaves. Forty (40) acres have been designated for a Memorial Monument Park that will include two Historical Cemeteries, a future Learning Center and a newly constructed Black Cowboy Museum. Programing will include connective trails from the new Memorial Monument Park to the historic sites of Newman Chapel and Oak Hill Cemeteries where freed slaves are interred. Trails will also connect and pay homage to a former Convict Leasing Program of the Texas Prisons System. These grant funds would support future programming activities, current site construction, and infrastructure improvements critically needed for the successful implementation of this Project.

1. African American Heritage Monument @ Bates Allen Park

- This Monument Park will honor and pay tribute to Black Trailblazers, such as Benjamin Franklin Williams, a former slave, clergyman and First Black Texas Legislator whose headstone is located on the site of the Monument. The monument will also include walking trails and reflection spaces for visitors to learn more about the rich history and contributions of African Americans in the country, the state, and the county. Notable descendants of Kendleton, Tx are Congresswoman Barbara Jordan, the first Black woman to serve in the Texas Senate and first Black State Senator in Texas since 1883, and Walter Moses Burton, the first Black Sheriff in U.S. history.

- The architectural firm for the project is Hines Architecture + Design, an African American firm headed by Damian S. Hines, AIA, NOMA, founder /principal. Damian is a black design architect and emerging critical voice in the design community. His projects are not just about design, but about advocating for design justice. He firmly believes that architecture can be a powerful tool in rewriting the narratives of communities with unjust histories, crafting bespoke and inclusive stories. Damian's journey led him to found Hines Architecture+Design, a global design practice that challenges the traditional mission and focus of a minority firm. Upon engaging Hines Architecture + Design (HAD), it was evident their commitment to providing superior customer experience was paramount. The entire team has demonstrated a deep understanding of our needs and have gone above and beyond to ensure our satisfaction. Their attention to detail and willingness to listen allowed them to tailor their services to align with the requirements of our project. We were totally blown away with the design concepts theorized in tandem with Fort Bend County's vision for this project. It was as if Hines Architecture + Design had a prophetic vision of what we envisioned and hoped to accomplish for this state-of-the-art piece of monumental history.

4. The Black Cowboy Museum

- Founded by Larry Callies, The Black Cowboy Museum is preserving the legacy of America's Black Cowboy. An experience at the Museum allows visitors to step into the boots of the likes of Bass Reeves, NatLove, and Bill Pickett. The museum, currently located in a store front in downtown Rosenberg, TX will move into its new location within the African American Experience at Bates Allen Park in 2026. It's collection of antique artifacts dating back to the early 1800's, include vintage irons, sewing machines, black powder guns, stoves, saddles, rows of barbed wire and a hall of fame room with photos of his long lineage of Cowboys and other notable, trailblazing Black Cowboys, showcasing the lifestyle and legacy of influence on Western culture.
