Kristen,

On 05/02/25 while waiting for our return flight in Birmingham AL airport during our extradition, our prisoner was transported by Birmingham EMS to a local hospital ER, where we spent 11 hours until he was discharged. While I accompanied the prisoner in the ambulance to the ER, Roger rented a vehicle at the airport and met us at the ER.

The prisoner remained in our custody, and after he was discharged on 05/03/25, we booked him into a local jail. There were no hotel rooms available at the government rate within 1.5 hours of Birmingham due to all the local colleges conducting graduation ceremonies, so we had no other option than to rent rooms at normal rates in order to get several hours of sleep before our 12 hour return drive to Houston. We drove overnight back to Houston IAH airport in the rental vehicle and arrived on 5/4/25. The rental car company advised there would be an extra charge incurred for returning the rental vehicle at IAH airport.

Lt. Carl was advised of all details during this process.

Also, while we were at the hospital with our prisoner, our return flights were cancelled due to weather.

All charges incurred during this extradition were unavoidable due to extremely extenuating circumstances.
