John Collins is an author, coach, consultant, and instructor at *Critical Victories* (<u>www.criticalvictories.com</u>) where he trains, educates, and mentors leaders to navigate sensitive, high-stakes situations through specialized communication and leadership. For over a decade, John has been a pioneering advocate of improved HR practices in forensic science organizations and the expanded integration of civilian employees into mainstream police practices.
