THIRD AMENDMENT TO SUBRECIPIENT AGREEMENT BETWEEN FORT BEND COUNTY AND SALVATION ARMY OF GREATER HOUSTON

THIS THIRD AMENDMENT, is made and entered into by and between Fort Bend County (hereinafter "County" or "Grantee"), a body corporate and politic under the laws of the State of Texas, and Salvation Army of Greater Houston, a non-profit corporation under the laws of the State of Texas, (hereinafter "Salvation Army" or Subrecipient").

WHEREAS, the parties have executed and accepted that certain Emergency Solutions Grant Program Subrecipient Agreement between Fort Bend County and Salvation Army of Greater Houston, (the "Agreement"), on or about April 23, 2024, and as amended on February 11, 2025 and May 13, 2025; and

WHEREAS, the parties desire to amend the Agreement to decrease the total Maximum Compensation under the Agreement; and

WHEREAS, the following changes are incorporated as if a part of the original Agreement incorporated by reference in the same as if fully set forth verbatim herein;

NOW, THEREFORE, the parties do mutually agree as follows:

- 1. County shall decrease the Payment Amount stated in Section V. by Forty-six Thousand Eight Hundred Forty-five dollars and no/100 (\$46,845.00).
- 2. The Maximum Compensation payable to Salvation Army for all Services rendered is hereby decreased to an amount not to exceed **Twenty-five Thousand One Hundred Fifty-Five Dollars and no/100** (\$25,155.00).
- 3. The Amended Budget stated in Section III. Budget and Allocation of Costs shall now read:

4. In no case shall the amount paid by County for all Services under the Agreement and this Amendment exceed the Maximum Compensation without an agreement executed by the parties.

Except as provided herein, all terms and conditions of the Agreement, including any addenda or amendments, not modified shall remain in full force and effect. If there is a conflict between this Amendment and the Agreement, the provisions of this Amendment shall prevail with regard to the conflict.
