Fort Bend County hereby provides notice of a Substantial Amendment to the 2025–2029 Consolidated Plan and the Program Year 2025 Annual Action Plan in accordance with the County’s Citizen Participation Plan and the U.S. Department of Housing and Urban Development (HUD) regulations at 24 CFR Part 91 and Part 570.

This amendment reflects language consistent with Executive Order *14151 Ending Radical and Wasteful Government DEI Programs and Preferencing*, Executive Order *14173 Ending Illegal Discrimination and Restoring Merit-Based Opportunity* and the Fiscal Year 2025 formula allocations authorized by the Consolidated Appropriations Act, Public Law 119-4, and updates to project funding.

Fiscal Year 2025 HUD Allocations

- Community Development Block Grant (CDBG): \$3,663,792.00
- HOME Investment Partnerships (HOME): \$991,188.52
- Emergency Solutions Grants (ESG): \$314,767.00

Proposed Program Year 2025 CDBG Activities

Public Services activities totaling \$549,569 allocated to eligible public service activities that primarily benefit low- and moderate-income persons through activities that meet the HUD National Objective of Low- and Moderate-Income (LMI) benefit (LMC – Limited Clientele).

Public Facilities & Infrastructure activities that enhance safety, accessibility, and community resilience and totaling \$2,381,465. Activities are expected to meet the HUD National Objective of Low- and Moderate-Income Area Benefit (LMA) or Urgent Need (UN).

Program Administration funds \$716,293 allocated to administrative and planning costs for the management, oversight, and compliance of the CDBG Program and are within the administrative cap permitted under HUD regulations.
