Introduction

The purpose of this program is to provide services and assistance directly to victims of crime to speed their recovery and aid them through the criminal justice process. Services may include the following:

- responding to the emotional and physical needs of crime victims;
- assisting victims in stabilizing their lives after a victimization;
- assisting victims to understand and participate in the criminal justice system; and
- providing victims with safety and security.

Forensic Medical Examination Payments

Health care facilities shall conduct a forensic medical examination of a victim of an alleged sexual assault if the victim arrived at the facility within 120 hours after the assault occurred and the victim consents to the examination. The victim is not required to participate in the investigation or prosecution of an offense as a condition of receiving a forensic medical examination, nor pay for the forensic examination or the evidence collection kit. Crime Victim Compensation funds may be used to pay for the medical portion of the exam unless the victim of sexual assault is required to seek reimbursement for the examination from their insurance carrier. If a health care facility does not provide diagnosis or treatment services for sexual assault victims, the facility is required to refer the victim to a facility that provides those services.

Confidentiality and Privacy

Applicant agrees to maintain the confidentiality of client-counselor information and research data, as required by state and federal law. Personally identifying information or individual information collected in connection with services requested, utilized, or denied may not be disclosed; or, reveal individual client information without informed, written, reasonably time-limited consent of the person about whom information is sought. If release of information is compelled by statutory or court mandate, reasonable attempts to provide notice to victims affected by the disclosure of information will be made and steps necessary to protect the privacy and safety of the persons affected by the release of information will be taken.

Activities that Compromise Victim Safety and Recovery

Applicant agrees to not engage in activities that jeopardize victim safety, deter or prevent physical or emotional healing for victims, or allow offenders to escape responsibility for their actions.

Polygraph Testing Prohibition

A peace officer or attorney representing the state may not require an adult or child victim of an alleged sex offense to submit to a polygraph examination or other truth telling device as a condition for proceeding with the investigation of such an offense. In addition, the refusal of a victim to submit to a polygraph or other truth telling examination will not prevent the investigation, charging, or prosecution of an alleged sex offense or on the basis of the results of a polygraph examination.

Protection Orders

Victims applying for a protective order or their attorney may not bear the costs associated with the filing of an order of protections.

Offender Firearm Prohibition

The applicant certifies that its judicial administrative policies and practices include notification to domestic violence offenders of the requirements delineated in section 18 USC § 992(g)(8) and (g)(9).

Criminal Charges

In connection with the prosecution of any misdemeanor or felony domestic violence offense, the victim may not bear the costs associated with the filing of criminal charges against a domestic violence offender, issuance or service of a warrant, or witness subpoena.

Cybersecurity Training Requirement

Local units of governments must comply with the Cybersecurity Training requirements described in Section 772.012 and Section 2054.5191 of the Texas Government Code. Local governments determined to not be in compliance with the cybersecurity requirements required by Section 2054.5191 of the Texas Government Code are ineligible for OOG grant funds until the second anniversary of the date the local government is determined ineligible. Criminal History Reporting

Entities receiving funds from PSO must be located in a county that has an average of 90% or above on both adult and juvenile dispositions entered into the computerized criminal history database maintained by the

Texas Department of Public Safety (DPS) as directed in the *Texas Code of Criminal Procedure, Chapter 66*. The disposition completeness percentage is defined as the percentage of arrest charges a county reports to DPS for which a disposition has been subsequently reported and entered into the computerized criminal history system.

Counties applying for grant awards from the Office of the Governor must commit that the county will report at least 90% of convictions within five business days to the Criminal Justice Information System at the Department of Public Safety.

Uniform Crime Reporting (UCR)

Eligible applicants operating a law enforcement agency must be current on reporting complete UCR data and the Texas specific reporting mandated by 411.042 TGC, to the Texas Department of Public Safety (DPS) for inclusion in the annual Crime in Texas (CIT) publication. To be considered eligible for funding, applicants must have submitted a full twelve months of accurate data to DPS for the most recent calendar year by the deadline(s) established by DPS. Due to the importance of timely reporting, applicants are required to submit complete and accurate UCR data, as well as the Texas-mandated reporting, on a no less than monthly basis and respond promptly to requests from DPS related to the data submitted.

Entities That Collect Sexual Assault/Sex Offense Evidence or Investigate/Prosecute Sexual Assault or Other Sex Offenses

In accordance with Texas Government Code, Section 420.034, any facility or entity that collects evidence for sexual assault or other sex offenses or investigates or prosecutes a sexual assault or other sex offense for which evidence has been collected, must participate in the statewide electronic tracking system developed and implemented by the Texas Department of Public Safety. Additionally, per Section 420.042 "A law enforcement agency that receives evidence of a sexual assault or other sex offense...shall submit that evidence to a public accredited crime laboratory for analysis no later than the 30th day after the date on which that evidence was received." A law enforcement agency in possession of a significant number of Sexual Assault Evidence Kits (SAEK) where the 30-day window has passed may be considered noncompliant.

Immigration Legal Services

PSO prioritizes funding of projects that provide a full spectrum of counseling, crisis services, and other direct victim services. PSO will not fund projects that focus primarily on immigration legal services and do not provide a significant level of other types of victim services.

Legal Representation in Divorce and Custody Cases

PSO limits eligibility for legal representation in divorce and custody cases to circumstances where the survivor has been directly victimized by intimate partner violence (IPV) within the last six (6) months. This may include physical violence, sexual violence, stalking, and psychological aggression (including coercive tactics) by a current or former intimate partner against the survivor or survivor's kin sharing the residence. Additionally, legal services in divorce and custody cases funded under this award are limited to emergency order assistance, safety planning, client representation in divorce or guardianship proceedings, and other family law matters directly resulting from the victimization. Through acceptance of this award, grantee agrees that reimbursement for divorce and custody-related legal services will be limited to circumstances listed above.

Discrimination

Applicant agrees not to discriminate against victims because they disagree with the State's prosecution of the criminal case.

Records

Applicant agrees to maintain daily time and attendance records specifying the time devoted to allowable victim services.

Volunteers

If awarded VOCA funds, applicant agrees to use volunteers to support either the project or other agency-wide services/activities, unless PSO determines that a compelling reason exists to waive this requirement.

Crime Victims' Compensation

Applicant agrees to assist crime victims in applying for crime victims' compensation benefits.

Civil Rights Information

Victims of Federal Crime

Applicant agrees to provide equal services to victims of federal crime. No Charge

Applicant agrees to provide grant-funded services at no charge to victims of crime. Applicants are also prohibited from billing Crime Victims Compensation, private insurance, Medicaid, or Medicare for services provided using VOCA funds.

Effective Services

Applicants applying for funds to provide victim services must demonstrate a record of providing effective services to crime victims. (See "Eligible Organizations" in the Funding Announcement.)

College Campus Confidential Direct Services Providers

All personnel compensated through OOG or match funds are Confidential Direct Service Providers that maintain victim's confidentiality for all case information (written or oral) and share information only at the victim's request and with the victim's informed consent, except when release of information is required by law. Confidential Direct Service Providers compensated with grant funds shall not be required to disclose client or case information to any entity, including a campus Title IX officer or coordinator, except when release of information is required by law. A victim may not be coerced or required to file a report or disclose information regarding their victimization with any entity as a condition of receiving services from a Confidential Direct Service Provider.

Failure to comply with this certification may result in PSO, at its sole discretion, withholding reimbursement on personnel line items contained in the program budget until satisfactory evidence of compliance is provided.

Compliance with State and Federal Laws, Programs and Procedures

Project Abstract :

With a rapidly growing population of approximately 944,637, Fort Bend County ranks among the fastest-growing counties in the United States. This growth has led to a rise in abuse cases, underscoring the urgent need for services for domestic violence victims. The Victim Case Coordinator Program is dedicated to addressing these needs. The victim case coordinator plays a vital role in working with multidisciplinary teams to coordinate and provide services. They support victims in restoring their quality of life by offering guidance, case information, and referrals for essential wraparound services. This grant will bolster investigation resources, expand assistance to victims, and provide specialized support for domestic violence victims.

Problem Statement :

In recent years, the Fort Bend Sheriff's Office has seen a worrying rise in domestic and intimate partner violence cases within the community. The victims, often women, children, and other vulnerable individuals, face complex challenges that extend far beyond the initial crisis. The growing number of cases and the resulting backlog make it difficult for the Criminal Investigations Division and the Victim Services team to meet all the victims' needs effectively. Before the establishment of a victim case coordinator role, investigating detectives spent a significant portion of their time providing victim coordination services, leaving them with little time to investigate the cases thoroughly. The high demand for dedicated support only exacerbates the challenges victims face, making it imperative for the FBCSO to maintain the Victim Case Coordinator position within our law enforcement framework. Key issues surrounding domestic violence include insufficient support services, underreporting, offender accountability, and victim safety. Victims of domestic and intimate partner violence suffer not only physical harm but also severe emotional trauma. Currently, our law enforcement lacks sufficient dedicated support to address these victims' holistic needs. The victim case coordinator helps bridge this gap by offering comprehensive assistance, addressing immediate safety concerns, responding to the emotional aftermath of incidents, and meeting the victims' needs. This grant will support the continuation and expansion of the Victim Case Coordinator role, providing additional investigative resources, support services, and specialized assistance to domestic violence victims, ensuring they receive the help they need to restore their quality of life.

Supporting Data :

The Fort Bend County Sheriff's Office has witnessed a significant rise in domestic violence cases, impacting women, children, and vulnerable adults. Recognizing this alarming trend, the 2022-2023 Fort Bend County Community Plan has identified domestic violence as a high priority, revealing a critical lack of support from multi-disciplinary services. The plan also highlights insufficient resources for prosecuting and following up on protective orders and criminal cases involving family violence. Between 2022 and 2023, the Fort Bend County Sheriff's Office experienced a 58% increase in assigned cases and a 110% rise in the number of victims seeking services. In 2024 alone, the family violence unit received 2882 cases of domestic abuse, with detective caseloads ranging from 25 to 40 new cases a month. Data from October to December 2023 show the following breakdown by ethnicity: 45 Asian, 243 Black/African American, 335 Hispanic or Latino, 351 White/Caucasian, and 30 of unknown race. The gender breakdown indicated 444 women, with 15 cases where the gender was not reported by the victim. Additionally, Child Advocates of Fort Bend served 2,420 child victims of abuse with 62% being girls & 385 being boys, while the Fort Bend County Women's Center provided service to 2,297 survivors of domestic violence. These figures underscore the growing need for support services for victims of domestic and intimate partner violence in Fort Bend County, as provided by our victim case coordinator. Our victim case coordinator plays a pivotal role in addressing these needs, collaborating with multidisciplinary teams to coordinate and provide comprehensive services. They work tirelessly to help victims restore their quality of life, offering guidance, case information, and referrals for essential wraparound services. This grant will enhance our capacity to provide additional investigative resources and specialized support for domestic violence victims, ensuring they receive the assistance they need.

Project Approach & Activities:

The Fort Bend County Sheriff's Office Victim Case Coordinator plays a crucial role in providing comprehensive

support to victims of crimes, particularly women and children. By collaborating with various stakeholders, including Child Protective Services (CPS), Adult Protective Services (APS), law enforcement, Child Advocates of Fort Bend, medical professionals, counselors, and forensic experts, the project aims to streamline coordination, enhance communication, and ensure victims receive timely and sensitive care throughout their recovery process. The Victim Case Coordinator conducts initial needs assessments to identify the specific needs and vulnerabilities of victims. By establishing protocols for timely case identification and referrals from relevant agencies, the coordinator ensures a safer and more secure service line for victims and their families. The project also develops a collaborative framework to facilitate communication and information sharing among community agencies and partners like APS, CPS, law enforcement, Child Advocates of Fort Bend, Fort Bend County Women's Center, medical professionals, counselors, and forensic experts. Participation in regular case review meetings helps ensure a coordinated approach to individual cases. Informational materials are prepared and distributed to enhance stakeholders' understanding of their roles and responsibilities. A victim-centered approach to case management is implemented, prioritizing the physical, emotional, and psychological needs of victims. The coordinator maintains a system for regular check-ins with victims to assess their well-being and address any emerging needs. A streamlined process for scheduling and coordinating forensic testing ensures timely and accurate results. Communication between medical professionals and law enforcement is facilitated to ensure seamless integration of medical care into the investigative process. The coordinator continues to provide a secure and confidential case management system for victims and increases collaboration with local organizations to expand the network of support services. Partnerships with forensic laboratories are established for expedited testing, and reports on project outcomes and impact are produced. This comprehensive approach ensures that victims receive the support they need from multiple angles, fostering a coordinated and compassionate response from the Victim Case Coordinator and the Sheriff's Office.

Capacity & Capabilities:

The Fort Bend County Sheriff's Office, under the leadership of Sheriff Eric Fagan, elected to office in 2021, is a robust organization with over 750 employees. These dedicated professionals operate across ten specialized divisions, organized into three bureaus and a training academy. Captain Scott Heinemeyer leads the Criminal Investigations Division (CID), which consists of experienced detectives, investigative specialists, and victim case coordinators. The CID excels in solving complex crimes, ensuring justice for victims and families, while upholding the highest standards of investigative excellence. The victim case coordinator plays a pivotal role in facilitating seamless collaboration among law enforcement, Child Protective Services (CPS), medical professionals, counselors, community stakeholders and forensic experts. This ensures that crime victims receive timely and sensitive care throughout the investigative process. The coordinator also arranges forensic testing, medical care, and counseling services to address the physical, emotional, and psychological needs of victims to help them navigate their recovery journey.

Performance Management :

To enhance the effectiveness of our Domestic Violence program at the Fort Bend County Sheriff's Office, it is crucial for the domestic violence coordinator to maintain a collaborative relationship with the Fort Bend County District Attorney's office. This strategic partnership aims to strengthen legal processes surrounding domestic violence cases, ultimately increasing conviction rates. By working closely with the DA's office, the coordinator can facilitate seamless information sharing, coordinated efforts, and joint initiatives that create a more robust legal framework for addressing domestic violence comprehensively. This collaborative approach not only focuses on securing more convictions but also emphasizes improving services for victims. Through effective communication and cooperation with the District Attorney's office, the domestic violence coordinator can ensure that victims receive comprehensive support and assistance throughout the legal proceedings. This includes streamlining victim services, coordinating with law enforcement, and implementing measures to enhance the overall well-being of those affected by domestic violence. The success of this program will be measured by the number of cases investigated by the Fort Bend County Sheriff's office, the number of cases resulting in charges being filed, the number of arrests made, the number of referrals to the DA's office for conviction, the number of restraining orders filed, and the number of services provided to victims/survivors.

Target Group :

The Family Violence Unit of the Fort Bend County Sheriff's Office is committed to addressing and investigating domestic violence offenses with a targeted focus on ensuring the safety and well-being of victims. Our primary target group includes women and children who have been victims of domestic violence. Fort Bend County has an estimated population of approximately 944,637, with 355,937 of these residents being adult females. The demographic breakdown of the county is 51.4% White, 24.7% Hispanic or Latino, 22.7% Asian, and 30% other ethnicities. Data indicates that 1 in 4 women will become victims of domestic abuse by an intimate partner. In 2023 Fort Bend County experienced a significant rise in domestic violence calls to 8,918. Our efforts aim to

provide support and justice for individuals who have experienced domestic violence, ensuring their safety and empowerment throughout the investigative process. This approach emphasizes the comprehensive work of the Family Violence Unit, focusing on both supporting victims and prosecuting offenders, with the overarching goal of fostering a community free from the devastating effects of domestic violence. The unit is dedicated to diligently investigating cases, providing support services to victims, and holding offenders accountable to create a safer and more secure living environment for all residents within Fort Bend County.

Evidence-Based Practices:

According to a comprehensive review conducted by the Texas Council on Family Violence (2022), over 300 homicide cases were analyzed, revealing that 216 Texans tragically lost their lives to intimate partner or stalking homicides. This underscores the critical need for targeted interventions and evidence-based policies to address the alarming prevalence of domestic violence in Texas and Fort Bend County. The findings from this extensive review emphasize the urgency of providing ongoing support and implementing effective strategies to prevent and respond to intimate partner abuse and stalking violence. This serves as a stark reminder of the profound impact domestic violence can have on individuals and communities, highlighting the imperative for evidence-based practices to enhance victim protection, offender accountability, and overall public safety. The Texas Council on Family Violence's research offers crucial insights that guide the development and refinement of policies aimed at addressing and curbing the tragic consequences of intimate partner abuse and stalking homicides in Texas. It is suggested that implementing laws prohibiting offenders from possessing firearms helps protect victims from potential escalation of violence. Additionally, in the Houston Area Domestic Violence Providers Study Initial Local DV Data Aggregation (Gregory, E., Hough, Z., & Martinez, I., 2023), it shows that two Houston area shelters (HAWC & Fort Bend Women’s Center) are currently building new facilities to expand capacity by 309 beds over the next two years. The study highlights that with the increase in domestic violence cases, the centers are often forced to use options like hotels and expanded alternative housing when funding is available, to augment their offerings to those in need. In 2024, the Fort Bend Women's Center provided emergency shelter to 409 women in need, 100 more victims than in 2023. At the FBCSO, we are recognizing the pressing need to address the growing demand for support to domestic violence victims and reducing barriers that victims face. We are committed to providing victim with emotional support to assist them while dealing feelings of shame, guilt and embarrassment. Assisting in building trust and helping survivors deal with fear of retaliation from their abusers. This support is a proactive response to the escalating challenges faced by survivors seeking safety and healing from abusive situations. This includes reducing barriers to reporting family violence and assault, taking a trauma-informed approach to understanding and responding to the impact of trauma on survivors, by assisting with ensuring victim safety, recognizing and respecting the diverse backgrounds and experiences of survivors. As well as, ensuring that comprehensive support services such as emergency shelters, financial assistance and community support are accessible to all survivors.

Additionally, counties and municipalities may NOT have in effect, purport to have in effect, or make themselves subject to or bound by, any law, rule, policy, or practice (written or unwritten) that would: (1) require or authorize the public disclosure of federal law enforcement information in order to conceal, harbor, or shield from detection fugitives from justice or aliens illegally in the United States; or (2) impede federal officers from exercising authority under 8 U.S.C. § 1226(a), § 1226(c), § 1231(a), § 1357(a), § 1366(1), or § 1366(3). Lastly, eligible grantees/applicants must comply with all provisions, policies, and penalties found in Chapter 752, Subchapter C of the Texas Government Code.
