NOTE 1: Longevity pay for Elected Officials was terminated effective October 1, 2007. All officials holding office on that date were "grandfathered" at the amount they then received, and newly elected officials will not receive longevity.

NOTE 2: County Court at Law Judges and District Court Judges are paid in accordance to SB 293 which bases the salary on longevity. Should the sitting judge at the time salaries are adopted change, the new judge will receive a base salary according to SB 293. Additionally, should a judge move tiers during the fiscal year, the new salary is not effective until their anniversary date. The salaries listed above are the salaries after the anniversary date.
