**2008 LOCAL OPTION EXEMPTIONS OFFERED**

**Homestead is 20% or 5,000 whichever is greater**

**Over 65 is 100,000 maximum**

**Disabled Persons is 100,000 maximum**

**\*\* Eligible Taxpayers may have either "Over-65" or "Disabled Persons" exemption but not both. Eligible Taxpayers receiving an "Over-65" or "Disabled Persons" exemption also receives the "Homestead" exemption.**

Note: Disabled Veterans is a state mandated exemption not a local option exemption
